Certificate Purpose: This certificate is for veterinary purposes only and the original must accompany the consignment.

Certificate is required by: The Ministry of Agriculture, Fisheries and Rural Development, Veterinary Administration.

**Section IV. Government Certificate's Legal Entry Requirements**

All certificates listed in this report, i.e. certificates that must accompany a product at the time of entry, must be originals.

A certificate can be applied to multiple shipments only if the goods in the shipment come from the same batch.

For the listed certificates, Croatia does not accept a Supplier's or Manufacturer's Export Declaration as proof of compliance.

For the listed certificates, Croatia will accept state-issued export certificates from the United States, if the state-issued certificates are in accordance with Croatian legislation.

**Section V. Other Certification/Accreditation Requirements**

Food for special nutritional purposes must have an approval from the Ministry of Health and Social Welfare before being placed on the market. However, food products for special nutritional purposes can be placed on the market without approval from the Ministry of Health and Social Welfare if a notice is sent to the Ministry about placing a specific product on the market together with an application of that product to the responsible institution in the EU and an adequate explanation in the Croatian language. Moreover, all food supplements and food enriched with nutrients must have a notification number from the Ministry of Health and Social Welfare. For details on the procedure, contact FAS Croatia
