While the United States has not received clear guidance from the General Administration of Customs of the Peoples Republic of China (GACC) on the implementation of Decrees 248 and 249, the U.S. Food and Drug Administration (FDA) has begun collecting information that may be needed to facilitate the registration process under Decree 248 before the new requirements go into effect on January 1, 2022. FDA's December 6 Constituent Update requesting that establishments that currently export certain food products to China voluntarily submit information to FDA can be found at this link.

While the United States government continues to press China for critical information about how GACC will apply Decree 248 to U.S. exports, FDA is collecting information in case lists are needed. GACC has not confirmed that this information is both required and sufficient for GACC to register U.S. establishments.
