# **Report Highlights:**

On December 30, 2020, Egypt's Minister of Trade and Industry (MTI) signed Decree No. 653/2020. The decree renewed an earlier decision that extended the shelf-life validity period for imported frozen fish from six to nine months and of frozen beef liver from seven to 10 months. The decree valid until June 30, 2021(see APPENDIX I – Unofficial English Translation).



#### **GENERAL INFORMATION**

The initial decision to extend the shelf-life period for these products was taken in April, 2020 to support food supply availability and facilitate trade amid the COVID-19 pandemic. (see: <u>GAIN Report</u> Number: EG2020-0020 Egypt Relaxes Shelf-Life Requirements for Frozen Fish and Beef Liver)

The <u>Egyptian Organization for Standardization and Quality</u> (EOS), remains the agency responsible for the determination of shelf-life periods in Egypt.

In calendar year 2019 (January-December), Egypt imported over 90,000 metric tons (MT) of beef offal (see figure 1). The United States supplies about 45,000 MT of beef offal, of which roughly 42,000 MT were beef livers.

## Minister of Trade and Industry, Decree No. 653/2020

Resolve:

#### Article (1):

Pertaining to the validity date (shelf-life) of frozen fish and frozen (beef) liver, imported as per Egyptian Standard No. 2,613-2/2008, its duration, and enforced through Decrees Nos. 285/2006 and 434//2008, it is determined that the duration for frozen fish is to be nine months and for frozen liver to be 10 months from slaughter.

#### Article (2):

This decree is valid from January 1, 2021 to June 30, 2021.

#### Article (3):

This decree is to be published in the official gazette, entering into force on the date of its publication.
