# **Report Highlights:**

On March 14, 2022, under the Egyptian prime minister's direction, the General Organization for Veterinary Services (GOVS) distributed a letter with instructions for its veterinary posts across the country. The instructions state that all milk and dairy products could enter Egypt without a halal certificate. However, another letter was distributed on March 16, 2022, stating that milk and dairy products are permitted to enter Egypt with a certificate, but no fees will be applied until October 1, 2022. Post is working with the GOE authorities to clarify if the certificate requirement will stand. What is clear for now is that no fees will be charged for halal certification until October 1, 2022.

THIS REPORT CONTAINS ASSESSMENTS OF COMMODITY AND TRADE ISSUES MADE BY USDA STAFF AND NOT NECESSARILY STATEMENTS OF OFFICIAL U.S. GOVERNMENT POLICY On March 14, under the Egyptian prime minister's direction, the General Organization for Veterinary Services (GOVS) distributed a letter of instructions to its veterinary posts across the country (attached Arabic annex 1 and English - unofficial translation – annex 2). The instructions state that all milk and dairy products are permitted to enter Egypt without a halal certificate. The instructions are valid and applicable until October 1, 2022; this resulted from a recommendation during a special committee convened by the Prime Minister on March 8, 2022. However, on March 16, GOVS issued a clarification letter (attached Arabic annex 3 and English - unofficial translation – annex 4), declaring that only the fees will be waived until October 1, 2022.

Contacts reported that starting March 1, 2022, they began to pay for halal certificates. However, these contacts report certificates are now required, but no fees are being charged.

What will happen after October 1, 2022 remains unclear. The draft halal standard that has been developed by the Egyptian Organization for Standardization (EoS) has yet to be approved or notified. (See: GAIN - EG2022-0005 Updates on Egypt's Halal Requirements)

Post sources report that they should convene again to discuss the EU comments on the draft standard, however, when this will be finalized is unclear to the whole committee.

The committee will convene again to discuss international comments on the Halal draft standard. It is still unclear even to the committee members when the draft will be finalized, but Post will continue to provide updates through the GAIN system on any new developments.
