This report was prepared by the USDA Foreign Agricultural Services in Maputo, Mozambique, for U.S. exporters of domestic food and agricultural products. While every possible care was taken in the preparation of this report, information provided may not be completely accurate either because policies have changed since its preparation, or because clear and consistent information about these policies was not available. It is highly recommended that U.S. exporters verify the full set of import requirements with their customers, who are normally best equipped to research such matters with local authorities, before any products are shipped. Final import approval of any product is subject to the importing country's rules and regulations as interpreted by border officials at the time of product entry.

All the sections of this report have been updated based on recent regulation amendments, updated website links, and to comply with the updated FAS reporting instructions. The report includes an assessment of laws and requirements for food and agricultural products imported into Mozambique.

Executive Summary

This report describes major Mozambique's required import documentation, their purpose, and the necessary attestations. It also includes government certificate legal entry requirements and other certification/accreditation requirements. Specific Mozambican government agencies involved in import/export certifications and their role are also included.

Section II: Purpose of Specific Export Certificates

The purpose of each certificate listed above is as follows:

- 1. **Veterinary Health Certificate:** Attest to food safety and quality and prevention of diseases. It is required by Ministry of Agriculture and Rural Development (MADER).
- 2. **Import Permit:** Attest to food safety and quality and prevention of diseases. It is required by MADER, the Ministry of Science and Technology, and the Ministry of Trade and Industry.
- 3. **Phytosanitary Permit:** Quarantine conformity and control/containment of the spread of pests and diseases. It is required by MADER.
- 4. **GMO Permit:** Product liability and control. It is required by the Ministry of Science and Technology.

Section III: Specific Attestations Required on Export Certificates

Mozambique's required certificates serve to attest:

- 1. **Veterinary Health Certificate:** MADER requires this certificate to confirm type of product and its composition, confirm product compliance with international norms and standards, and confirm that the product is not from areas affected by avian diseases.
- 2. **Import Permit:** Required by both MADER and the Ministries of Science & Technology and Trade & Industry, the import permit grants import authorization and confirms that the product meets international standards.
- 3. **Phytosanitary Permit:** Required by MADER to attest to phytosanitary status in conformity with the specific regulation, this permit also verifies country of origin and that the product conforms to international standards.
- 4. **GMO Permit:** Required by the Ministry of Science & Technology, the GMO permit grants import approval for genetically engineered products and authorizes testing only in Mozambique.

Section V: Other Certification/Accreditation Requirements to Ensure Market Entry

Certificate of Origin: Mozambique requires that imported goods are accompanied by a certificate of origin that must be obtained from the product provider at the locale of origin, per local revenue authority requirements. Mozambique has different agreements with foreign countries, like SADC and the EU, from which certificates of origin are given different import benefits.
