Report Highlights:

China extended again the Section 301 retaliatory tariff exclusions on 11 agricultural products, including shrimp for cultivation, whey for feed, fishmeal for feed, alfalfa and six hardwood products. The 11 agricultural tariff lines are part of a list of 81commodities that had their Chinese Section 301 retaliatory tariff exclusions extended through April 16, 2022.

General Information

On September 16, 2021, the Ministry of Finance published Tariff Commission Announcement No. 7 (2021) of the State Council Customs Tariff Commission (SCCTC), which extends retaliatory Section 301 tariff exclusions on 81 U.S. tariff lines, including 11 agricultural product categories, through April 16, 2022. The exclusions were set to expire on September 16, 2021. Unofficial Translation of the SCCTC Announcement

The State Council Customs Tariff Commission (SCCTC) Announcement Regarding the Fifth Exclusion and Extension of U.S. Products Imposed with Additional Tariffs

Tariff Commission Announcement No. 7 (2021)

According to the State Council Customs Tariff Commission Announcement Regarding the First Exclusion and Extension Lists of U.S. Products Imposed with Additional Tariffs (Tariff Commission Announcement No. 8 (2020) and the State Council Customs Tariff Commission Announcement Regarding the Third Exclusion and Extension Lists of U.S. Products Imposed with Additional Tariffs (Tariff Commission Announcement No. 2 (2021), the first exclusion and extension list of U.S. products imposed with additional tariffs and the third exclusion and extension list of U.S. products imposed with additional tariffs will expire on September 16, 2021. The SCCTC has decided, in accordance with procedures, to extend the exclusion period for the below-mentioned commodities. The relevant issues are now announced as follows:

For the 81 commodities listed in the Annex, the exclusion period stipulated in the Tariff Commission Announcement No. 8 (2020) and the Tariff Commission Announcement No. 2 (2021) will be extended through April 16, 2022, and no retaliatory Section 301 tariffs will be imposed.

Annex: The fifth exclusion list to be extended for the U.S. products imposed with additional tariffs (see <u>the fifth</u> <u>exclusion and extension list</u>).
