Report Highlights:

On August 23, 2022, the Sri Lankan government temporary suspended the import of 26 agricultural products. The Imports and Exports (Control) Regulations No. 13 (2022) is a quantitative import restrictive measure. The Sri Lankan government is ordering the temporary suspension of the import of 300 non-essential items, 26 items of which are food and agricultural products. Agricultural commodities subject to import suspension include condensed milk, yoghurt, chocolate, and other food preparations containing cocoa, oats, liquid coconut milk, beverages made of vegetables, milk, cereal, and tree nuts, and coconut-base arrack (distilled spirit). The new regulation should have limited impact on the trade of U.S.-origin agricultural commodities in terms of trade value.

GENERAL INFORMATION

The Sri Lankan government is revising its import control regulations in stages since March 19, 2020. These revisions began as a means of managing the impact of the COVID-19 pandemic and intended to limit the outflow of foreign exchange reserves. Sri Lanka introduced quantitative and price restrictions on imports to discourage the import of non-essential commodities.

The Imports and Exports (Control) Regulations No. 13 (2022) is a quantitative import restrictive measure. The Sri Lankan government is ordering the temporary suspension of the import of 300 non-essential items, 26 items of which are food and agricultural products. This import suspension is effective August 23, 2022. However, goods shipped with the date of bill of lading/airway bill issued on or before August 23, 2022, and with an arrival at any of Sri Lanka's seaports or airports on or before September 14, 2022, have been allowed to clear Sri Lanka Customs and entry into the country.

Sri Lanka's revised regulations seek to maintain the uninterrupted supply of raw materials for export processing. They are not applicable to enterprises/operators, approved under the Temporary Importation for Export Purposes (TIEP) Scheme of the Sri Lanka Customs or any enterprises, approved under Section 17 of the Board of Investment of Sri Lanka (BOI) Act, No. 4 of 1978 for processing and re-export purposes including on "No Foreign Exchange (NFE)" basis. The import of any goods, specified in Table 1 (Appendix I) of these regulations, by any approved enterprises for processing and re-export purposes may be allowed by the Controller General of Imports and Exports Control premised on the recommendation of the Secretary, Ministry of Industries or the Director General, Export Development Board of Sri Lanka, on a case-by-case basis.

As per the notification, any other requests for the import of any goods specified in Table 1 for direct use, may be allowed by the Controller General of Imports and Exports Control and subject to the Ministry of Finance's recommendation to the Secretary to the Treasury on a case-by-case basis. As such, the Controller General of Imports and Exports shall charge a documentation fee of Sri Lankan rupees (LKR) 2,000 (~\$5.54) per invoice.

Agricultural Commodities Affected: Agricultural commodities subject to import suspension include condensed milk, yoghurt, chocolate, and other food preparations containing cocoa, oats, liquid coconut milk, beverages made of vegetables, milk, cereal, and tree nuts, and coconut-base arrack (distilled spirit). The new regulation should have limited impact on the trade of U.S.-origin agricultural commodities in terms of trade value.

¹ Sri Lankan coconut-based arrack is distilled from the sap of the coconut flower. This arrack type is best described as a fragrant dark coconut rum.
