On May 2, 2012, the Food Safety and Standards Authority of India, Ministry of Health and Family Welfare, published a corrigendum on the 'guidelines (dated March 23, 2012) related to the food import clearance procedure by the FSSAI's authorized officers.'

**General Information:**

On March 23, 2012 the Food Safety and Standards Authority of India (FSSAI) published “Guidelines Related to Food Import Clearance Process by FSSAI’s Authorized Officers”.
