GOI amends Import Requirements for Poultry and Poultry Products

Report Highlights:

On February 17, 2017, the Government of India (GOI) notified amendments to the requirements for poultry and poultry product imports from countries reporting an outbreak of Highly Pathogenic Avian Influenza or Low Pathogenic Avian Influenza. The regulation has not been notified to the World Trade Organization (WTO) to date.

On February 17, 2017 GOI published a gazette notification to amend the requirements for poultry and poultry product imports from countries reporting avian influenza. The amendment is issued in order to rectify the inadvertent omission of the term "the areas of low pest or disease prevalence" in the paragraph 1(d) of the earlier notification (Please see IN6095 and IN6105). The amended text should now be read as "Pest-or disease-free areas and areas of low pest or disease prevalence means the pest-or disease-free areas and areas of low pest or disease prevalence as defined in the World Trade Organization Agreement on Sanitary and Phytosanitary Measures." The previous amendment for the import requirements for the poultry and poultry product from countries reporting avian influenza was made on September 21, 2016 (Please see IN6122). GOI had also earlier published a procedure for the recognition of zones/compartments free from avian influenza; this procedure can be accessed at guidelines for recognition of disease free areas, zones and compartments and questionnaire to ascertain the avian influenza situation in a zone.

NOTIFICATION

O. 510(E).— In exercise of the power conferred by sub-section (1) of section 3 and 3A of the Livestock Importation Act, 1898 (9 of 1898), the Central Government hereby makes the following notification further to amend the notification of the Government of India in the Ministry of Agriculture and Farmers Welfare (Department of Animal Husbandry, Dairying and Fisheries) published in the Gazette of India, Extraordinary, Part II, Section 3, Sub-section (ii), vide number S.O. 2337 (E), dated the 8th July, 2016 namely,-

In the said notification in paragraph 1 for clause (d) the following shall be substituted, namely,

'(d) Pest-or disease-free areas and areas of low pest or disease prevalence means the pest or disease free areas and areas of low pest or disease prevalence as defined in the World Trade Organization Agreement on Sanitary and Phytosanitary Measures'.
