Report Highlights:

On September 17 2018, the Government of India's (GOI) Ministry of Finance (MOF) extended the implementation date of an increase in the Basic Custom Duty on several U.S. agricultural products (i.e. shelled and in-shell almonds, in-shell walnuts, fresh apples, and pulses) by another 45 days, until November 2, 2018.

On September 17, 2018, the MOF issued notification <u>62/2018</u> announcing a 45-day delay, from September 18, 2018 to November 2, 2018, for implementation of increases in the effective Basic Custom Duty (BCD) on certain U.S. agricultural imports. If implemented, these tariff increases would apply only to U.S.-origin shelled and in-shell almonds, in-shell walnuts, apples, and pulses.

Background Information:

On August 3, 2018, the MOF issued notification <u>56/2018</u> announcing a 45-day delay, from August 4, 2018 to September 18, 2018, for tariff increases on certain U.S. agricultural imports to go into effect.

On June 20, 2018, the MOF issued notifications <u>48/2018</u> and <u>49/2018</u> announcing tariff increases on certain U.S.-origin agricultural products, effective August 4. For more information, see GAIN <u>IN8093</u>.
