The 8th edition of the [Food and Grocery Forum India \(FGFI\)](#) and concurrent informational sessions will be held from January 14-16, 2015 in Mumbai, India. FAS India will be present at the show to help file trade leads from prospective Indian buyers and provide on-site assistance to participating USDA Cooperators, companies, and other stakeholders. Firms interested in exploring the Indian retail sector may find this show a useful platform.

The 8th edition of the Food and Grocery Forum India will be held from January 14-16, 2015 in Mumbai, India, at the Bombay Exhibition Center. This three-day trade show will be combined with information sessions and presentations on issues affecting India's food retail sector. The show is sponsored by the Forum of Indian Food Importers and the National Restaurant Association of India and is organized by the Images Group in association with the Ministry of Food Processing.

The educational sessions provide information on issues that affect commercial decisions and include information on Indian food laws and regulations, changes in consumption patterns, the development of new commercial hubs, private labeling, etc. Presentations and discussions typically include representatives from India's leading retailers, food processors and industry consultants.
