Report Highlights:

On November 7, 2025, the General Administration of Customs of China (GACC) published the Announcement on the Requirements for Declaration Management of Overseas Enterprises for Imported Agricultural Products, with an enforcement date of December 15, 2025. This report includes an unofficial translation of the announcement and its associated product catalog. U.S. facilities that export relevant agricultural products to China are encouraged to conduct their own review on the announcement and assess any market or regulatory impact on their business.

FAS China provides this reporting and analysis as a service to U.S. farmers, ranchers, rural communities, and agribusinesses in support of a worldwide agricultural information system and a level playing field for U.S. agriculture.

Report Summary:

On November 7, 2025, the General Administration of Customs of China (GACC) published an [*Announcement on the Requirements for Declaration Management of Overseas Enterprises for Imported Agricultural Products*](#) (in Chinese). This announcement officially published the first [*Catalog of Imported Agricultural Products Requiring Overseas Official Recommendation for Registration*](#) (Catalog) (in Chinese) and mandates that importers ensure all imported products listed in the Catalog originate from foreign facilities that are officially registered with the Department of Plant and Animal Quarantine, GACC. The announcement also highlights a [platform](#) where importers and overseas facilities can verify registration status. Importers are required to accurately include the Chinese registration number of the foreign facility on customs declaration forms or filing lists. These requirements will enter into force on December 15, 2025.

This report includes an unofficial translation of the announcement and the Catalog (attached). U.S. facilities that export relevant agricultural products to China are encouraged to conduct their own review on the announcement and assess any market or regulatory impact on their business. The Catalog consists of 18 sheets, one for each of the following categories:

- 1) Aquatic animals and genetic materials
- 2) Poultry and genetic materials
- 3) Animal-derived feed and additives (including pet food)
- 4) Non-edible animal products (including fertilizers, etc.)
- 5) Animal-derived traditional Chinese medicinal materials
- 6) Terrestrial animals and genetic materials (excluding poultry)
- 7) Grains (including miscellaneous grains, pulses, and oilseeds)
- 8) Plant seedlings (only those with published import phytosanitary requirements and requiring overseas enterprise registration)
- 9) Organic cultivation substrates/medium
- 10) Plant-derived fertilizers
- 11) Plant-derived feed (including forage grass)
- 12) Plant products for processing (including raw coffee, cocoa, stevia, mesona chinensis, etc.)
- 13) Fresh fruits
- 14) Fresh vegetables
- 15) Plant-derived traditional Chinese medicinal materials
- 16) Plant-derived seasonings
- 17) Substances traditionally used as both food and traditional Chinese medicines
- 18) Others

U.S. exporters and U.S. facilities planning to export certain agricultural commodities to China that are subject to the purview of the Department of Animal and Plant Quarantine of GACC and require official recommendation for registration, please refer to [GAIN report CH2025-0113](#) for detailed guidance.

BEGIN UNOFFICIAL TRANSLATION

General Administration of Customs Announcement No. 219 of 2025

(Announcement on the Requirements for Declaration Management of Overseas Enterprises for Imported Agricultural Products)

To further strengthen traceability management of imported agricultural products and improve customs clearance efficiency, in accordance with the relevant provisions of the *Law of the People's Republic of China on Entry-Exit Animal and Plant Quarantine* and its implementing regulations, the requirements for declaration management of overseas enterprises for imported agricultural products are hereby announced as follows:

1. In accordance with international phytosanitary measure standards, the General Administration of Customs conducts risk analysis on the quarantine of imported agricultural products and, in line with international practices, determines and publicly releases the *Catalog of Imported Agricultural Products Requiring Overseas Official Recommendation for Registration* (hereinafter referred to as "the *Catalog*"). The *Catalog* can be accessed at <http://dzs.customs.gov.cn/dzs/2747042/6787828/index.html>. Importers shall ensure that imported agricultural products listed in the *Catalog* originate from overseas enterprises with normal registration status as published by customs.
2. Registered overseas enterprises can be queried through the *List of Registered Overseas Enterprises for Entry Animal and Plant Products and Their Products* at <http://dzs.customs.gov.cn/dzs/2747042/6787828/index.html>, or through the "Animal and Plant Quarantine Information Query" function under the "I Want to Check" section of the "Internet + Customs" platform at <https://online.customs.gov.cn/ociswebserver/pages/dzjxxcx/index.html>.
3. When declaring agricultural products listed in the *Catalog* for importation, the importers shall enter the Chinese registration number (registration number in China) of the overseas enterprise in the certificate field of "Registration of Overseas Production, Processing, and Storage Enterprises for Entry Animal and Plant Products and Their Products" (permit category code 302) under the "Product Qualification" section of the customs declaration form or filing list. Where multiple commodity items are involved in the same customs declaration form, the corresponding Chinese registration number (registration number in China) of the enterprise shall be filled in for each item.

This announcement shall be implemented from December 15, 2025.

This is hereby announced.
