## **Report Highlights:**

On March 27, 2025, The People's Republic of China National Health Commission and the State Administration for Market Regulation jointly released the Amendment Sheet for the National Food Safety Standard for Raw Milk. The amendment entered into force on its publication. China notified the draft revision to the WTO on October 25, 2023. This report provides unofficial translation of the amendment sheet. Stakeholders should conduct their own review of the regulations to assess any market or regulatory effect on their business.

#### **Report Summary:**

On March 27, 2025, The People's Republic of China's (China's) National Health Commission (NHC) and the State Administration for Market Regulation (SAMR) jointly released the Amendment Sheet No. 1 for the National Food Safety Standard for Raw Milk, which revised the acidity indicator for cow milk. On October 25, 2023, China notified the draft amendment to the WTO under <u>G/SPS/N/CHN/1288</u>. The final amendment entered into force on its publication date.

This report contains unofficial translation of the Amendment to the National Food Safety Standard for Raw Milk (<u>GB 19301-2010</u>) (link in Chinese). Stakeholders should conduct their own review of the regulations to assess any market or regulatory effect on their business.

### **BEGIN UNOFFICIAL TRANSLATION**

#### GB 19301-2010 National Food Safety Standard for Raw Milk No. 1 Amendment

The amendment was approved jointly by the National Health Commission of the People's Republic of China and China State Administration for Market Regulation on March 16, 2025 by Announcement No. 2, and it entered into force on the date of its approval.
