Report Highlights:

This report lists all official controls on food and agricultural products by commodity description and HS Code. It also provides an exhaustive list of import or transit documents that must accompany foods, feeds, byproducts of animal origin, seeds and planting materials, insects, bacteria, mushrooms, live animals and germplasm, wood and wood products, packaging materials, and agricultural raw materials for industrial use. Ukraine's regulation establishing these requirements was adopted in April 2018 but was amended significantly in November 2024. This report replaces the FAIRS Subject UP1833 report.

This report was prepared by the Office of Agricultural Affairs in Kyiv, Ukraine, for U.S. exporters of domestic food and agricultural products. While every possible care has been taken in preparing this report, the information provided may not be completely accurate either because policies have changed since its preparation or because clear and consistent information about these policies was unavailable. It is highly recommended that U.S. exporters verify the full set of import requirements with their foreign customers, who are normally best equipped to research such matters with local authorities before any goods are shipped. Executive Summary:

Ukraine introduced [changes](#) (link in Ukrainian) to the List of Products Subject to Official Control at Border Inspection Posts in October 2024 by updating Cabinet of Minister's [Resolution #960-2018](#) (link in Ukrainian). This resolution established lists of products subject to veterinary and sanitary control and certification, and phytosanitary control and certification, as well as controls and certification applied to foods, feeds, byproducts of animal origin, and animal welfare. This regulation also establishes an exhaustive list of documents that will be required from the exporter.

This FAIRS subject report replaces the earlier FAIRS UP1833 GAIN Report “[Product Groups Subject to Official Control](#).”

Report Reader's Guide:

- First, the U.S. exporter should identify its product correctly. Ukraine uses the 10-digit Ukrainian version of the International HS system to set import controls. It coincides with the international version up to the 6th digit. Be sure to use the HS Code of your product and the product description from Tables 1, 2, and 3 to identify your product correctly. The exception, when only the HS Code is to be used for product identification, is marked by a **** sign next to the HS Code.
- Second, the exporter must identify the controls that will be applied to the products in question by browsing Tables 1, 2, and 3 of Chapter I of this report.
Note: Please explore all three tables, as one product can be subject to multiple controls. If necessary, familiarize yourself with wood packaging requirements.
- Third, the exporter will identify a comprehensive list of necessary documents in Chapter II of this report. The exporter is advised to consult with the importer as to the accuracy of the document list at the time of shipment. The exporter is also advised to reference FAS/Kyiv's most recent Food and Agriculture Import Regulation and Standards [Country Report](#) for other importing requirements and FAIRS [Certificate Report](#) for the list of available bilateral certificates (both links are up-to-date when this report was submitted, but reports are reviewed annually).

Ukraine uses the requirements in the International Standard for Phytosanitary Measures No. 15 "Regulation wooden packaging material in international trade." During the customs clearance process, Ukraine's official "[Single Window for International Trade](#)" (in Ukrainian) web portal automatically assigns controls based on the current risk criteria. The State Service for Food Safety and Consumer Protection (SSUFSCP) of Ukraine [publishes](#) (in Ukrainian) updates on its official website regarding the phytosanitary controls of product-accompanying wood packaging material.

** Subject to [control on compliance with Ukrainian regulations on foodstuffs, feedstuffs, byproducts of animal origin, and animal health and welfare](#) (in Ukrainian). Controls are applied when the product is imported into the customs territory of Ukraine (imports for transit purposes are excluded).

*** Section 2 is not subject to veterinary and sanitary control in the form of preliminary documentary control carried out by the customs authority at crossing points.

**** When customs authorities conduct preliminary documentary control at checkpoints (control points) across Ukraine's state border, they should be guided exclusively by the Ukrainian HS product code. In all other cases, both the product description and the code should be considered.

Note: In case of custom declaration of imported products as "organic," or in cases when "organic" labeling is discovered during inspection, the SSUFSCP official conducts certification verification as required by Article 37 of the Law of Ukraine "[On Basic Principles and Requirements to Organic Production, Circulation and Labeling of Organic Products](#)" (in Ukrainian).
