# Report Name: Burma Reduces List of Products that Require Import Licenses

#### **Report Highlights:**

In October 2020, the Ministry of Commerce published notification 68/2020, which reduced the number of tariff lines that require an import license. As of December 1, 2020, 689 tariff lines no longer require an import license. However, 3,931 tariff lines, including the majority of U.S. agricultural exports to Burma, still require an import license.

### Myanmar Ministry of Commerce Notification 68/2020

#### **Background:**

Each year, the Burmese Ministry of commerce (MOC) reviews the list of tariff lines that require importers to apply for an import license. Burma currently uses the 2017 version of its Harmonized Tariff schedule, which is available <u>here</u>. With a goal of continued trade facilitation and liberalization, MOC identified 689 tariff lines that no longer require import licenses during its 2020 review, and published this via notification 68/20 on October 22, 2020. These changes went into effect on December 1, 2020.

The following agricultural products no longer require an import license:

- 0403: Buttermilk, curdled milk and cream, yogurt, kephir and other fermented or acidified milk and cream, whether or not concentrated or containing added sugar or other sweetening matter or flavored or containing added fruit, nuts or cocoa.
- 0404: Whey, whether or not concentrated or containing added sugar or other sweetening matter; products consisting of natural milk constituents, whether or not containing added sugar or other sweetening matter, not elsewhere specified or included.
- 0405: Butter and other fats and oils derived from milk; dairy spreads.
- 0406: Cheese and curd.
- 1517: Margarine; edible mixtures or preparations of animal or vegetable fats or oils or of fractions of different fats or oils of this Chapter, other than edible fats or oils or their fractions of heading 15.16.
- 1601: Sausages and similar products, of meat, meat offal or blood; food preparations based on these products.
- 1602: Other prepared or preserved meat, meat offal or blood.
- 1603: Extracts and juices of meat, fish or crustaceans, molluscs or other aquatic invertebrates.
- 16.04: Prepared or preserved fish; caviar and caviar substitutes prepared from fish eggs
- 1605: Crustaceans, molluscs and other aquatic invertebrates, prepared or preserved
- 2201: Waters, including natural or artificial mineral waters and aerated waters, not containing added sugar or other sweetening matter nor flavored; ice and snow.
- 2202.10: Waters, including mineral waters and aerated waters, containing added sugar or other sweetening matter or flavored
- 2202.10: Sparkling mineral waters or aerated waters, flavor
- 2202.99: Other
- 2202.99: Flavored UHT milk based drinks
- 2202.99: Soya milk drinks
- 2202.99: Coffee based drinks or coffee flavored drinks

- 2202.99: Other non-aerated beverages ready for immediate consumption without dilution

However, 3,931 tariff lines, including the majority of U.S. agricultural exports to Burma, still require an import license. The updated list of products is available <u>here</u>. The translation of the title of the table is, "List of goods required to apply import license, according to a chapter by HS Code 2017 Version."

The previous pages, which are in Burmese, are provided in English below.

#### **Impact to U.S. Exports**

Although the majority of U.S. agricultural exports to Burma still require an import license, this notification does streamline import procedures for the small number of products listed above.

Ministry of Commerce Notification No. 68/2020 The 6th Waxing Day of Thadingyut, 1382 M.E. (22<sup>nd</sup> October, 2020)

In accordance with Article 13 (b) of the Export Import Law, The Ministry of Commerce has issued this Notification.

### Issuance of the list of goods required to apply import license

1. The tariff lines required to apply import license are being reviewed for trade facilitation annually, some tariff lines are released the list of non-licensing requirements and 3931 tariff lines are issued a list of goods required to apply import license, according to HS code 2017 version, including the group of goods such as live animal, meat, fish, various edible oil, vegetable and cereal crops, forest products, beverages, mineral fuels, mining products, chemical products, medicines, vehicle and machineries, wastes, etc., with the objectives of State security, food security and protection of environmental problems.

2. The prohibited goods for import permits according to the related law, regulations and rules; and specific issued goods to allow importation according to specific directives and procedures, will be complied in accordance with the related law, regulations, rules, directives and procedures.

3. This Notification will come into effect on 1st December, 2020 and if tariff lines without including the list of licensing requirements issued by the Notification No. 22/2019 are comprised within 3931 tariff lines provided by 10 digits of this notification, such tariff lines are required to apply import license after 90 days of the announcement of this Notification.

4. This Notification prevails over the Notification No. 22/2019 dated 21.5.2019 issued by the Ministry of Commerce.
