Report Highlights:

On December 23, 2020, the State Council Tariff Commission (SCTC) announced its annual tariff adjustment plan that sets tentative import and export tariff rates for select tariff lines in 2021. In this announcement, China lowered the tentative tariff rates for certain dairy products, certain wood products and made changes to the calculation for out-of-quota cotton tariff rates. The tentative tariff rates are applicable to tariff lines from all exporting countries. This report contains an unofficial translation of the SCTC notice and the list of agriculture-related tariff lines subject to tentative applied MFN tariff rate changes in 2021.

General Information:

At the end of each year, the SCTC sets tentative import and export tariff rates for select commodities to be applied during the following year. At the same time, SCTC also announces China's tariff rate quotas (TRQ) for all products. On December 23, 2020, the Ministry of Finance published on its website a SCTC notice (dated December 21), releasing its 2021 tariff adjustment plan. The applied MFN import tariffs for certain dairy and wood products will be further lowered in 2021 (see Annex 1). The announcement also provides a new equation for calculating out-of-quota tariff rates for cotton (see Annex 3). The remaining agricultural tariff rates remain unchanged from the previous announcement. The tentative tariff rates are applicable to all exporting countries.

This GAIN report contains an unofficial translation of the SCTC notice, including the food and agricultural products listed in Annex 1 of the notice and the corresponding applied MFN tariff rates and TRQs listed in Annex 3 for 2021. The SCTC announcement does not change China's retaliatory tariffs on U.S. exports or the tariff exclusion process for these products.

Notable Tariff Reductions and HS Code Changes in 2021:

In 2021, certain dairy import tariffs such as anhydrous lactose (HS 17021100) will be tentatively lowered to 5 percent from the current 10 percent. Whey protein powder and lactoferrin, both under HS 35022000, have been added and will be tentatively lowered from 10 percent to 5 percent. Special dairy-based infant formula food (HS 19011010) for premature /low birth weight babies and nutrition supplement for breast milk, will be set to 0 percent in 2021. However, the tentative tariffs for regular infant formula milk powders that share the same code HS 19011010 will remain unchanged at 5 percent.

Many wood products such as fiberboard for which MFN tariffs have been tentatively lowered in the previous years will see their import tariffs further reduced in 2021.

The SCTC has also adjusted HS codes for a few agricultural products. For example, the HS code for frozen capelin has been changed to HS 03035990 (previously, HS 03035900). Similarly, the HS codes for frozen Atlantic salmon and frozen Danube salmon have been changed to HS 03031310 and HS 03031320, respectively. However, the MFN rates for Atlantic salmon and Danube salmon remain unchanged.

Lastly, the SCTC has redefined the product description (or product scope) for certain products such as that for special infant formula food under HS 21069090.

Notable Change to out-of-quota Cotton Calculation

In 2021, SCTC adjusted the sliding rate calculations for out-of-quota cotton imports. Changes indicated in **red** below.

- 1) When the dutiable price of imported cotton is greater than or equal to **14.000 RMB** (*lowered from 15.000 RMB in 2020*) per kilo, the tentative tariff rate will be **0.280 RMB per kilo** (*lowered from 0.300 in 2020*);
- 2) When the dutiable price of imported cotton is less than 14.000 RMB (*lowered from 15.000 RMB in 2020*), the tentative tariff rate will be calculated based on the following formula: Ri=9.0/Pi+2.69%*Pi-1 (*previously Ri=9.45/Pi+2.6%*Pi-1 in 2020*)
 The calculation result of the above formula will be rounded to three decimal places. Ri refers to tentative tariff rate. When the calculation result of the above formula is greater than 40 percent, the value of Ri should be 40 percent. Pi refers to dutiable price (unit: RMB/kilo).

Notice of the State Council Tariff Commission on Tariff Adjustment Plan in 2021

SCTC Notice No.33 (2020)

December 21, 2020

The General Administration of Customs of the People's Republic of China (GACC),

In an effort to support the expedited formation of the new development structure and facilitate high quality economic development, the import tariffs for some commodities will be adjusted as of January 1, 2021 based on relevant provisions of *the Import and Export Tariff Regulation of the People's Republic of China*. The 2021 Tariff Adjustment Plan is printed and delivered to your Administration. Refer to the Appendix for details.

Appendix: The 2021 Tariff Adjustment Plan

The State Council Tariff Commission

1. Most Favored Nation (MFN) Tariff Rate

- 1) Tentative import tariff rates will be applied to a total of 883 tariff lines (not including commodities subject to TRQ) as of January 1, 2021. The tentative import tariffs on 9 information technology (IT) product tariff lines will end on July 1, 2021 (see Annex 1).
- 2) The MFN tariff rates on IT products listed in the annex of Amendment to the Tariff Schedule of the People's Republic of China to the World Trade Organization will be reduced for the sixth time on July 1, 2021 (see Annex 2).

2. TRQ Tariff Rate

TRQ management will continue to apply to eight categories of commodities including wheat and the tariff rates will remain unchanged. Of which, a tentative one percent TRQ tariff rate will apply to three fertilizers including urea, compound fertilizer, and diammonium phosphate. A sliding tax will continue to be levied on out-quota imported cotton within a certain amount and it has been adjusted (see Annex 3).

3. Conventional tariff rates and special preferential tariff rates

1) Based on the trade agreements and preferential tariff arrangements signed between China and certain countries or regions, the conventional tariff rates with New Zealand, Peru, Costa Rica, Switzerland, Iceland, Australia, South Korea, Chile, Georgia, and Pakistan, who have signed a bilateral trade agreement or Asia-Pacific Trade Agreement with China, will be further reduced as of January 1, 2021, unless previously agreed conventional tariff rates that have been approved by the State Council. Of which, the conventional tariff rates applicable to the Asia-Pacific Trade Agreement will be applied to some commodities imported from Mongolia as of January 1, 2021. In accordance with the provisions of the bilateral trade agreement between China and Switzerland and the Asia-Pacific Trade Agreement, the conventional tariff rates will be further reduced as of July 1, 2021 (see Annex 7).

2) Based on the Free Trade Agreement between the Government of the People's Republic of China and Government of the Mauritius Republic, the first year's conventional tariff rates for certain commodities from Mauritius will be applied as of January 1, 2021 (see Annexes 3, 7).

3) When MFN tariff rates are lower or equal to the conventional tariff rates, they shall be implemented in accordance with the provisions of relevant agreements if there are such provisions. If there are no such provisions, the lower rates shall apply.

4) The special preferential tariff rates will continue to be applied to the least developed countries who have established diplomatic relations with China and have completed the process of the exchange of letters. The scope of applicable commodities and tariff rates will remain unchanged. II - Export tariff rates will continue to be applied

Export tariffs will continue to be applied to 107 tariff line commodities including ferrochrome with applicable export tariff rates or tentative export tariff rates as of January 1, 2021. The scope of commodities subject to export tariffs and the export tariff rates will remain unchanged (see Annex 4).

III-Adjustments on tariff lines and notes

To accommodate the needs of industrial development and trade administration, some tariff lines and notes have been adjusted (Annex 5, 6). After the adjustments, the tariff lines will total 8,580 in 2021.

IV- Implementation time The above plan will be implemented on January 1, 2021 unless otherwise specified.

The specific formula is as follows:

- 1) When the dutiable price of imported cotton is greater than or equal to **14.000 RMB** per kilo, the tentative tariff rate will be **0.280 RMB per kilo**;
- 2) When the dutiable price of imported cotton is less than **14.000 RMB**, the tentative tariff rate will be calculated based on the following formula:

Ri=9.0/Pi+2.69%*Pi-1

The calculation result of the above formula will be rounded to three decimal places. Ri refers to tentative tariff rate. When the calculation result of the above formula is greater than 40 percent, the value of Ri should be 40 percent. Pi refers to dutiable price (unit: RMB/kilo).

Note (2, 3), (4): Tentative tariff rate is one percent.
