Report Highlights:

On June 16, 2023, Egypt notified the World Trade Organization (WTO) of a new halal requirement and procedure for food products via a Technical Barriers to Trade (TBT) addendum notification. The notification postpones the halal certification requirement on imported milk and dairy products until October 1, 2023.

EGYPT'S SIXTH NOTIFICATION ON DAIRY HALAL CERTIFICATION REQUIREMENT

On June 16, 2023, the Government of Egypt (GOE) issued a WTO/TBT addendum (Annex 1) extending the requirement for halal certification of imported milk and dairy products until October 1, 2023. This is the sixth addendum filed by the GOE to the WTO regarding milk and dairy halal certification since December 2021 (see: <u>GAIN EG2023-0001Egypt Extends the Implementation of Halal Certification on Milk and Dairy Product until April 1 2023</u>).

Although the certificates are not technically required per the notification, Post industry contacts report that importers continue to present the certificates. They are also reporting that they are not paying any halal certification fees for imported milk and dairy products.

Post encourages U.S. suppliers and shippers to remain in close contact with Egyptian importers for the latest updates on halal certificate requirements.
