Final Amendment on Pullulan as a Food Additive

Report Highlights:

The Government of India's (GOI) Food Safety and Standards Authority of India (FSSAI) amended the <u>Food Safety and Standards (Food Product Standards and Food Additives) Regulations, 2011</u>, to include pullulan as a food additive.

Executive Summary:

FSSAI published the <u>Food Safety and Standards (Food Product Standards and Food Additives)</u> <u>Amendment Regulations, 2015</u>, to include pullulan as a food additive. The final amendment is based on public comments received from various stakeholders on the draft regulations published on December 8, 2014 (<u>IN4115</u>).

No P. 15025/263/13-PA/FSSAI.—Whereas the draft of the Food Safety and Standards of India (Food Products Standards and Food Additives) (Amendment) Regulations, 2014, were published as required under sub-section (1) of section 92 of the Food Safety and Standards Act, 2006 (34 of 2006), vide notification of the Food Safety and Standards Authority of India number F.No. P. 15025/263/13-PA/FSSAI, dated the 17th October, 2014 in the Gazette of India, Extraordinary, Part III, Section 4, dated the 17th October, 2014, inviting objections and suggestions from the persons likely to be affected thereby, before the expiry of the period of thirty days from the date on which the copies of the Official Gazette containing the said notification were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 17th October, 2014;

And whereas the objections and suggestions received from the public in respect of the said draft regulations have been considered by the Central Government;

Now, therefore, in exercise of the powers conferred by clause (e) of sub- section (2) of section 92 read with section 16 of the said Act, the Food Safety and Standards Authority of India hereby makes the following regulations

further to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, namely:-----

REGULATIONS

1. Short title and commencement.—(1) These regulations may be called the Food Safety and Standards (Food Products Standards and Food Additives) (Amendment) Regulations, 2015.

(2) They shall come into force on the date of their publication in the Official Gazette.

 In the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, in regulation 3.1 relating to "Food Additives",-

(a) in sub-regulation 3.1.17 relating to "Other substances to be used in Specified limits", in the TABLE, after serial number 19 and the entries relating thereto, the following serial number and entries shall be inserted, namely:—

Sl.No.	Substances	Food	Maximum level of use (ppm) mg/kg

"20.	Pullulan (thickening and glazing agent)	Dairy based desserts, such as pudding, fruit or flavoured yoghurt,etc., Fat-based dessert excluding dairy based dessert products of food category 1 mentioned above. Pre-cooked pastas and noodles and like products. Seasoning and condiments.	GMP".
