# **Final Amendment on Food Product Standards and Labeling Regulations**

## **Report Highlights:**

On July 25, 2016, the Government of India's (GOIs) Food Safety and Standards Authority of India (FSSAI) published notifications to amend the Food Products Standards and Packaging and Labeling Regulations, 2011. The amendments are specific to fatty acids, dietary fiber, packaging, and labeling related to plant sterols, isomaltulose, and high-fiber dextrin in various food products.

FSSAI notified its (i) Food Safety and Standards (Food Product Standards and Food Additives) Fourth Amendment Regulations, 2016, regarding the use of arachidonic acid (ARA), cocosahexaenoic acid (DHA), isomaltulose, and high fiber dextrin in various food products; and (ii) Food Safety and Standards (Packaging and Labeling) Third Amendment Regulations, 2016, regarding the use of plant sterosls (phytosterols), isomaltulose, and high fibre dextrin. Both amendments are finalized and effective as of the date of publication in the official Gazette, i.e., July 13, 2016.

**No. 3-14F/Notification (Nutraceuticals) /FSSAI-2013.**—Whereas the draft Food Safety and Standards (Food Products Standards and Food Additives) Amendment Regulations, 2014 were published as required under sub- section (1) of section 92 of the Food Safety and Standards Act, 2006 (34 of 2006), *vide* notification of the Food Safety and Standards Authority of India number No. 3-14F/ Notification(Nutraceuticals)/FSSAI-2013, dated the 11<sup>th</sup> December, 2014 in the Gazette of India, Extraordinary, Part III, Section 4, inviting objections and suggestions from persons likely to be affected thereby, before the expiry of period of sixty days from the date on which the copies of the Gazette containing the said notification were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 6<sup>th</sup> February, 2015;

And whereas the objections and suggestions received from the public in respect of the said draft regulations have been considered by the Food Safety and Standards Authority of India;

Now, therefore, in exercise of the powers conferred by clause (e) of sub- section (2) of section 92 read with section 16 of the said Act, the Food Safety and Standards Authority of India hereby makes the following regulations further to amend the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, namely:-

#### Regulations

1) **Short title and commencement.-** (1) These regulations may be called the Food Safety and Standards (Food Products Standards and Food Additives) Fourth Amendment Regulations, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

- (A) In Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011 (hereinafter referred to as the said regulations), in regulation 2.1, in sub- regulation 2.1.9,-
  - (i) in clause 2, after the first paragraph, the following paragraph shall be inserted, namely:-

"It may contain algal and fungal oil as sources of Docosahexaenoic Acid (DHA) and Arachidonic Acid (ARA) from Crypthecodinium cohnii, Mortierella alpina, Schizochytrium sp., and Ulkenia sp. at the level of maximum 0.5 per cent. DHA of total fatty acids and ratio of ARA: DHA as 1:1 minimum:

Provided that DHA content shall not be less than 0.2 per cent. of total fatty acids, if a claim related to the addition of DHA is made.";

(ii) in clause 5, after the first paragraph, the following paragraph shall be inserted, namely:-

"It may contain algal and fungal oil as sources of Docosahexaenoic Acid (DHA) and Arachidonic Acid (ARA) from Crypthecodinium cohnii, Mortierella alpina, Schizochytrium sp., and Ulkenia sp. at the level of maximum 0.5 per cent. DHA of total fatty acids and ratio of ARA:DHA as 1:1 minimum :

Provided that DHA content shall not be less than 0.2 per cent. of total fatty acids, if a claim related to the addition of DHA is made.".

(B) In the said regulations, in regulation 2.7, -

(i) in sub-regulation 2.7.1, after Sl. No. (xxv), the following Sl. No. shall be inserted, namely:-

"(xxvi) Isomaltulose at 50 per cent. (Max) of the total sugars without adversely affecting the stability of the product";

(ii) in sub-regulation 2.7.2, after Sl. No. (xvii), the following Sl. No. shall be inserted, namely:-

"(xviii) Isomaltulose at 50 per cent. (Max) of the total sugars without adversely affecting the stability of the product";

(iii) in sub-regulation 2.7.3, after Sl. No. (h), the following Sl. No. shall be inserted, namely:-

"(i) Isomaltulose at 50 per cent. (Max) of the total sugars without adversely affecting the stability of the product";

(iv) in sub-regulation 2.7.4, after the first paragraph, the following paragraph shall be inserted, namely:-

"The product may contain Isomaltulose at 50 per cent. (Max) of the total sugars without adversely affecting the stability of the product.";

(v) in sub-regulation 2.7.5, after the second paragraph, the following paragraph shall be inserted at the end, namely:-

"The ice lollies or edible ices and ice candy may contain Isomaltulose at 50 per cent. (max) of the total sugars without adversely affecting the stability of the product."

(C) In the said regulations, in regulation 2.11, after sub-regulation 2.11.7, the following sub-regulation shall be inserted, namely -

"2.11.8: Dietary Fibre (Dextrin – soluble fibre) means glucose polymer of natural origin obtained by dextrinification, i.e. dry roasting acidified starch under specific conditions and further purified. The average degree of polymerization of Dietary Fibre (Dextrin – soluble fibre) is from 12-25 compared to several thousand for starch. Unlike starches and maltodextrins, which contain only "digestible"  $\alpha$ - (1, 4) and  $\alpha$ - (1, 6) glucosidic linkages, Dietary Fibre (Dextrin – soluble fibre) also shall contain "indigestible"  $\alpha$ - and  $\beta$ - linkages.

Dietary Fibre (Dextrin-soluble fibre) may be used in the following food products at the level of Good Manufacturing Practices (GMP). It shall bear the label declaration as provided in serial number (54) of sub-regulation 2.4.5 of the Food Safety and Standards (Packaging and Labelling) Regulations, 2011, and the source of the ingredients (wheat/maize) shall be Non- Genetically Modified (GM):

Sl. No. (1)	Article of food (2)
1.	Flakes and ready-to-eat dry breakfast cereals
2.	Noodles and pasta
3.	Salad dressing or toppings and spreads
4.	Table top fibre as filler or carrier and cereals
5.	Other snack food or savouries
6.	Bakery products including biscuit, cookies, bread, cakes mix and pastries
7.	Other products where dextrin is allowed under these regulations.

Provided that in above products if it is intended to make claims on source of dietary fibre, it shall not contain less than 3g/100g or 1.5g/100Kcal:

Provided further that in above products if it is intended to make claims on high source of dietary fibre, it shall contain not less than 3g/100g or 1.5g/100 kCal and not more than 6g/100g or 3g/100 kCal".

No. 3-14P/Notification(Nutraceuticals)/FSSAI-2013.—Whereas the draft Food Safety and Standards (Packaging and labeling) (Amendment) Regulations, 2014 and the draft of the Food Safety and Standards (Packaging and labelling) (Amendment) Regulations, 2015 were published as required under sub- section (1) of section 92 of the Food Safety and Standards Act, 2006 (34 of 2006), *vide* notification of the Food Safety and Standards Authority of India number No. 3-14P/ Notification(Nutraceuticals)/FSSAI-2013, dated the 11<sup>th</sup> December, 2014 and F. No. 3-17/Phytosterol/Notification(Labelling)/FSSAI-2014, dated the 30<sup>th</sup> July, 2015 respectively in the Gazette of India, Extraordinary, Part III, Section 4, inviting objections and suggestions from persons likely to be affected thereby, before the expiry of a period of sixty days from the date on which the copies of the Gazette containing the said notifications were made available to the public;

And whereas the copies of the said Gazette were made available to the public on the 6<sup>th</sup> February, 2015 and 28<sup>th</sup> August, 2015 respectively;

And whereas objections and suggestions received from the public in respect of the said draft regulations have been considered by the Food Safety and Standards Authority of India;

Now, therefore, in exercise of the powers conferred by clause (k) of sub- section (2) of section 92 read with section 16 of the said Act, the Food Safety and Standards Authority of India hereby makes the following regulations further to amend the Food Safety and Standards (Packaging and Labeling) Regulations, 2011, namely:-

#### Regulations

2. Short title and commencement.- (1) These regulations may be called the Food Safety and Standards (Packaging and labelling) Third Amendment Regulations, 2016.

(2) They shall come into force on the date of their publication in the Official Gazette.

2. In Food Safety and Standards (Packaging and labelling) Regulations, 2011, in regulation 2.4, in sub-regulation 2.4.5, after serial number (52), the following serial numbers shall be inserted, namely:-

"(53) Every package of food product containing Isomaltulose shall bear the following declaration, namely:-

Contains Isomaltulose----- (calories)

(54) Every package of flakes and ready to eat dry breakfast cereals, noodles, pasta, salad dressings or toppings and spreads; table top fibre as filler or carrier, cereals and other snack food or savouries and bakery products including biscuits, cookies, bread, cake mix and pastries and other products where dextrin is allowed under these regulations containing added Dietary Fibre (Dextrin-soluble fibre), shall bear the following declarations, namely:-

Contains Dietary Fibre (Dextrin) ----- (Source of soluble Dietary Fibre)

(55) Fat spread, milk products, milk based fruit drink, fermented milk products, soy and rice drinks, cheese products, yoghurt products, spice sauces, salad dressings, juices and nectars, edible oils, and bakery products containing plant sterol shall contain the following declarations, namely:-

- Contains Plant Sterol (as Phytosterols) ---g/100g or 100ml.
- Patients on cholesterol lowering medication should use the product under medical supervision
- May not be nutritionally appropriate for pregnant and lactating women and children under the age of five years.
- CONSUMPTION OF MORE THAN 3g/DAY,TOTAL OF STEROL, STANOLS, OR COMBINATION THEREOF, SHOULD BE AVOIDED"
