# Food Import Regulations Supersede Certain Advisories and Guidelines

### **Report Highlights:**

On July 13, 2017, the Government of India's (GOI) Food Safety and Standards Authority of India (FSSAI) issued an order to list certain advisories and guidelines previously issued over the years' on imported food products as invalid. The 2017 Food Import Regulations include the subject matter of these advisories/guidelines and therefore supersede them.

#### <u>ORDER</u>

The Food Authority had issued order or advisory or guideline, from time to time for ensuring the safety and wholesomeness of food articles imported into India. The advisories at serial no. 1 to 8 and serial no. 9 to 11 are covered under FSS Food (Import) Regulations, 2017 and FSS (Food Product Standards and Food Additives) Amendment Regulations, 2016 respectively. Hence, the following advisories are superseded by the above mentioned regulations and are no more in force.
