#### **Report Highlights:**

This report outlines regulatory requirements for food and agricultural products exported to New Zealand. The sections on food laws, copyright and trademarks laws have been updated since the last report

#### Section I: List of All Export Certificates Required By Government

#### Summary

The Ministry of Primary Industries (MPI) is the key organization that regulates food imported into New Zealand. In 2011, the New Zealand Food Safety Authority (NZFSA) and Biosecurity New Zealand (BNZ) merged with the Ministry of Agriculture and Forestry (MAF). In April 2012, the Ministry of Fisheries was then merged with the expanded MAF to create the Ministry for Primary Industries (MPI).

The MPI has the lead role in biosecurity protection (e.g. preventing unwanted pests and diseases being imported into New Zealand, and controlling, managing or eradicating them should they arrive). New Zealand has strict biosecurity rules and most unprocessed products cannot be imported into New Zealand unless an import health standard has been developed. New Zealand defines biosecurity as "the exclusion, eradication or effective management of risks posted by pests and diseases to the economy, environment and human health." New Zealand's biosecurity requirements cover terrestrial, freshwater and marine environments. Import health standards specify the biosecurity requirements that must be met for trade to occur.

In New Zealand, import health standards are based upon risk analyses, which assess either a commodity or a pest/pathway combination. Biosecurity New Zealand takes legislative requirements and international obligations into account when conducting risk analyses and developing import health standards. The principal document for all New Zealand import health standards is the Biosecurity Act (1993). The act provides for management of risks associated with imported goods such as produce, seeds and plants principally through import health standards. New Zealand also adheres to the guidelines on risk analysis developed under the auspices of the Interim Commission on Phytosanitary Measures operating within the framework of the International Plant Protection Convention, and the World Trade Organization Agreement on the Application of Sanitary and Phytosanitary Measures.
