#### Section II: PURPOSE OF SPECIFIC EXPORT CERTIFICATE

The purpose of each certificate listed above is as follows:

- 1. Veterinary Health Certificate: Food safety and quality, and prevention of diseases. It is required by Ministry of Agriculture & Rural Development.
- 2. **Import Permit**: Food safety and quality, and prevention of diseases. It is required by both Ministries of Agriculture & Rural Development, Science & Technology, and Trade & Industry.
- 3. **Phytosanitary Permit**: Quarantine conformity, and control/containment of spread of pests/diseases. It is required by Ministry of Agriculture & Rural Development.
- 4. **GMO Permit**: Product liability and control. It is required by the Ministry of Science & Technology.

#### Section III: SPECIFIC ATTESTATION REQUIRED ON EXPORT CERTIFICATE

Mozambique required certificates serve to attest:

- 1. Veterinary Health Certificate: The Ministry of Agriculture and Rural Development requires this certificate to confirm type of product and its composition, confirm product compliance with international norms and standards, and confirm that product is not from areas that are declared affected by bird diseases.
- 2. **Import Permit**: It is required by both Ministries of Agriculture & Rural Development, Science & Technology, and Trade & Industry to attest import authorization, and confirm if product meets international standards
- 3. **Phytosanitary Permit**: It is required by the Ministry of Agriculture and Rural Development to attest phytosanitary status in conformity with the specific regulation, verify if it follows international standards, and the country of origin.
- 4. **GMO Permit**: It is required by the Ministry of Science & Technology to attest approval of import and authorization for testing only in Mozambique.

#### **Certificate of Origin**

Mozambique requires that imported goods are accompanied with certificate of origin that must be obtained from the product provider at the local of origin, as per local revenue authority requirements. Mozambique has different agreements with foreign countries, from which certificates of origin are given different import benefits, like SADC and the EU.
