# **Report Name:** India - More Time for Implementation of Integrated Veterinary Health Certificate for Importing Milk and Milk products

## **Report Highlights:**

On August 7, India's Department of Animal Husbandry and Dairying (DAHD) published Office Memorandum L-11/1/2019-Trade (E-11542) granting another three-month extension in the implementation of the integrated veterinary health certificate for import of milk and milk products. As per DAHD's July 10, 2024, notification, the implementation of the integrated veterinary health certificate was to begin from August 1, 2024, but as per the recent notification, implementation will begin from November 1, 2024, owing to requests from the Indian industry and a joint FAS-USTR request.

## **GENERAL INFORMATION:**

On August 7, 2024, India's Department of Animal Husbandry and Dairying (DAHD) published on its website **Office Memorandum (OM) L-11/1/2019-Trade (E-11542)**, announcing a delay in the implementation of its integrated veterinary health certificate (VHC) requirements for import of milk and milk products to October 31, 2024. The implementation will now begin from November 1, 2024 (see Appendix I). Earlier, in July 2024, DAHD notified an extension of timeline for implementation to July 31, 2024, but it was not implemented owning to a combination of requests from concerned Indian importers and a joint FAS – U.S. Trade Representative (USTR) request.

DAHD's recent memorandum notes that shipments of milk and milk products from all exporting countries after October 31, 2024, must have a bill of lading and an integrated VHC to comply with the requirements, as published by DAHD on March 31, 2023 (see, <u>GAIN- INDIA-IN2023-0030-Got Milk-India's DAHD Publishes Its Integrated Veterinary Health Certificate for the Import of Milk and Milk Products</u>).

Background: On March 31, 2023, India's Ministry of Fisheries, Department of Animal Husbandry and Dairying (DAHD), published its integrated veterinary health certificate (VHC) for the import of milk and milk products into India. The integrated VHC incorporates the DAHD's sanitary requirements along with those of the Ministry of Health and Family Welfare/Food Safety and Standards Authority of India's (FSSAI) food safety requirements. The integrated VHC needs to be certified by the exporting country's authority for consignments being exported to India (see, GAIN-INDIA-IN2023-0030-Got Milk- India's DAHD Publishes Its Integrated Veterinary Health Certificate for the Import of Milk and Milk Products). On July 17, 2023, the DAHD published Office Memorandum to grant additional transition time to stakeholders before implementation began on the requirements of VHC for the import of milk and milk products into India. That modified implementation date was December 31, 2023 (see, GAIN-INDIA-IN2023-0053-India-Implementation of Transition Period for the Integrated Veterinary Health Certificate for Imports of Milk and Milk Products). However, on January 3, 2024, the DAHD granted another six months in response to requests received from U.S. government and Indian industry stakeholders. It was extended from 31, December to June 30, 2024 (see, GAIN-INDIA-IN2024-0001-Timeline for Implementation of Integrated Veterinary Health Certificate Gets Another Extension), and then from June 30, 2024 to July 31, 2024 (see, GAIN-INDIA-IN2024-30- India Extends Timeline for Implementation of Integrated Veterinary Health Certificate for Milk and Milk products).

#### OFFICE MEMORANDUM

Subject: Veterinary Health Certificate for Import of Milk and Milk Products into India – regarding.

Vide this Department's O.M. of even number, dated 31<sup>st</sup> March, 2023 (copy enclosed), the Integrated Veterinary Health Certificate for Import of Milk and Milk Products into India, encorporating DAHD's sanitary requirements and FSSAI's food safety requirements was issued which has to be certified by the exporting country along with the consignments to be exported into India. Further, vide this Department's O.M. of even number, dated 17<sup>th</sup> July, 2023 (copy enclosed), the transition / migration time was increased till 31<sup>st</sup> December, 2023. Subsequently, vide this Department's O.M. of even number, dated 3<sup>rd</sup> January, 2024 (copy enclosed), the transition / migration time was increased till 30<sup>th</sup> June, 2024 and again vide this Department's O.M. of even number, dated 10<sup>th</sup> July, 2024 (copy enclosed), the transition / migration time was increased till 31<sup>th</sup> July, 2024

2. Now, the transition / migration time has been again extended till 31<sup>th</sup> October, 2024. The imported consignments of milk and milk products having bill of lading / date of issuance of Veterinary Health Certificate from exporting countries after 31<sup>st</sup> October, 2024 will only be considered for post-import clearance based upon Integrated Veterinary Health Certificate for Import of Milk and Milk Products into India.

3. This has the approval of the Hon'ble Minister for Fisheries, Animal Husbandry and Dairying.
