Report Highlights:

On October 27, 2022, the Ministry of Health and Family Welfare/Food Safety and Standards Authority of India (FSSAI) issued a new order pertaining to FSSAI Order F. No. 1829/Health Certificate/ FSSAI/Imports (2021), which extends the effective compliance date. The new effective compliance date is now set for January 1, 2023 (the previous effective compliance date was November 1, 2022). The measure is intended to allow India's trade partners to comply with the FSSAI's requirement that health certificates, issued by the competent authority of the country of export, accompany imports of milk and milk products; pork and pork products; and fish and fish products. The extension, a temporary reprieve, results from comments received, and concerns raised, by World Trade Organization (WTO) members regarding the FSSAI Order of August 8, 2022, referencing the FSSAI Notification No. 1829/Health Certificate/FSSAI/Imports (2021), along with FSSAI clarification notification of September 26, 2022.

GENERAL INFORMATION

On October 27, 2022, the Ministry of Health and Family Welfare/Food Safety and Standards Authority of India (FSSAI) issued a new order pertaining to **FSSAI Order F. No. 1829/Health Certificate/ FSSAI/Imports (2021)**, which extends the effective compliance date (see, Appendix I). The new effective compliance date is now set for January 1, 2023 (the previous effective compliance date was November 1, 2022).

The new order extends the effective compliance date of **FSSAI Order F. No. 1829/Health Certificate/FSSAI/Imports (2021)** by a period of up to two months. The measure is intended to allow India's trade partners to comply with the FSSAI's specific certificate requirements and attestations for health certificates, issued by the competent authority of the country of export, to accompany import consignments of milk and milk products; pork and pork products; and fish and fish products. The extension, a temporary reprieve, results from comments received, and concerns raised, by World Trade Organization (WTO) members.

Background:

The FSSAI notification **F. No. 1829/Health Certificate/FSSAI/Imports (2021)** (dated August 3, 2022), stipulated that effective November 1, 2022, all milk and milk products; pork and pork products; and fish and fish products imported into India require a health certificate issued by the competent authority of the exporting country in the format published in the FSSAI notification (see, <u>GAIN-INDIA IN2022-0069 – India's FSSAI Issues Notification Requiring Health Certificate to Accompany Imports of Milk and Milk Products – Pork and Pork Products – Fish and Fish Products).</u>

The FSSAI, in response to WTO members comments on the **FSSAI Order of August 8, 2022**, referencing the earlier **FSSAI Notification No. 1829/Health Certificate/FSSAI/Imports (2021)**, subsequently issued a clarification notification on September 26, 2022. This clarification notification results from WTO members' comments finding the FSSAI requirements to be duplicative; since

sanitary/veterinary certificates for milk and milk products, pork and pork products, and fish and fish products are already being issued by the exporting country's competent authority.

The FSSAI, through the clarification notification of September 26, 2022, confirms it will now be accepting for the import of milk and milk products, pork and pork products, and fish and fish products the presentation of an integrated/single health certificate. The FSSAI does, however, stipulate that the integrated/single certificate must still incorporate all the FSSAI mandated food safety related requirements/attestations necessary for import clearance in India (see, <u>GAIN-INDIA IN2022-0082 - India's FSSAI Issues Clarification Notice on its Requirement that Health Certificates Accompany Imports of Milk and Milk Products - Pork and Pork Products - Fish and Fish Products). The new effective compliance date is January 1, 2023.</u>
