#### **Report Highlights:**

On September 3, 2021, India's Ministry of Commerce and Industry/Directorate General of Foreign Trade (DGFT), issued Notification No. 23/2015-2020 pertaining to the "Inclusion of Ports of Import in Continuation to Notification No. 20/2015-20 (August 24, 2021)." This notification authorizes the inclusion of three additional seaports, capable of receiving bulk shipments of soybean meal, in addition to the existing two ports of Nhava Sheva (India's largest container port) and LCS Petrapole (a land port on the India-Bangladesh border). The three additional seaports, include: Mumbai Seaport (INBOM1), Tuticorin Seaport (INTUT1), and Vishakhapatnam Seaport (INVTZ1). The measure is meant to facilitate the import of up to 1.2 million metric tons of soybean meal destined for India's livestock production.

#### **GENERAL INFORMATION**

On September 3, 2021, the Directorate General of Foreign Trade (DGFT), Ministry of Commerce and Industry (MoCI) issued Notification No. 23/2015-2020 pertaining to the "Inclusion of Ports of Import in Continuation to Notification No. 20/2015-20 (August 24, 2021)" (see, Appendix I).

This notification authorizes the inclusion of an additional three seaports, capable of receiving bulk shipments of soybean meal, in addition to the existing two ports of Nhava Sheva (India's largest container port) and LCS Petrapole. The three additional seaports, include:

- Mumbai Seaport (INBOM1)
- Tuticorin Seaport (INTUT1)
- Vishakhapatnam Seaport (INVTZ1)

These three additional seaports included allow for imports under Notification No. 20/2015-20 (August 24, 2021). ### MARKET ACCESS ACHIEVED

On August 24, 2021, the Directorate General of Foreign Trade published Notification No. 20/2015-2020 in the Gazette of India Extraordinary (official gazette) permitting Indian traders to import 1.2 million metric tons (MMT) of soybean meal and soy cake derived from GE-soybeans through October 31, 2021 (see, <u>GAIN-INDIA – IN2021-0102 – India Officially Permits Limited Soybean Meal Imports</u>). The DGFT is the national authority that governs all agricultural import requirements (see, <u>GAIN-INDIA – IN2021-0096 – India - A Thumbs Up for Soybean Meal Imports Possible</u>).

In the Directorate General of Foreign Trade's notification of August 24, 2021, the Ministry of Environment, Forest, and Climate Change (MOEFC) specifies that "Since soya de-oiled and crushed (DOC) cake does not contain any living modified organism (LMO), this Ministry has no concerns and no objections for imports of soya cake from [sic] environmental angle."

i. Mumbai Sea Port (INBOM1)
ii. Tuticorin Sea Port (INTUT1)
<ol> <li>Vishakhapatnam Sea Port (INVTZ1)</li> </ol>
<ol> <li>All other conditions as mandated under Notification 20/2015-20 dated 24<sup>th</sup> August 2021 shall continue to apply.</li> </ol>
Effect of the Notification: The ports of Mumbai Sea Port (INBOM1), Tuticorin Sea Port (INTUT1), Vishakhapatnam Sea Port (INVTZ1) have been additionally included for allowing imports as under Notification 20/2015-20 dated 24.08.2021.
