Report Highlights:

On June 29, 2021, the Food Safety and Standards Authority of India (FSSAI) published a new directive changing the nomenclature "Blended Edible Vegetable Oil" or "Multi Source Edible Vegetable Oil" now to simply "Multi Source Edible Oil." At the Food Authority 33rd Meeting, the FSSAI (authority) determined to remove the term 'vegetable' and change the terminology as "Multi Source Edible Oil" wherever specified in the food safety and standards regulations. The authority is extending the compliance timeline now until November 17, 2021, when conformity with the new mandatory labeling and display regulations come into effect. Earlier, the effective compliance date had been set for June 8, 2021. The Food Safety and Standards Authority of India, in response to stakeholders' requests, is extending the compliance date to allow food business operators (industry) additional time to exhaust existing inventory of product labels.

GENERAL INFORMATION

On June 29, 2021, the Food Safety and Standards Authority of India (FSSAI) published a new directive changing the nomenclature "Blended Edible Vegetable Oil" or "Multi Source Edible Vegetable Oil" now to simply "Multi Source Edible Oil." At the Food Authority 33rd Meeting, the FSSAI (authority) determined to remove the term 'vegetable' and change the terminology as "Multi Source Edible Oil" wherever specified in the food safety and standards regulations. The authority is extending the compliance timeline now until November 17, 2021, when conformity with the new mandatory labeling and display regulations come into effect. Earlier, the effective compliance date had been set for June 8, 2021.

In response to stakeholders' requests, the FSSAI is extending the compliance date to allow food business operators (industry) additional time to exhaust existing inventory of product labels. Similarly, the extension affords industry the possibility to better comply with the new labeling requirements pertaining to font size and nomenclature of multi-source edible oil, among others.

The directive also notes that effective November 17, 2021, the Food Safety and Standards (Prohibition and Restrictions on Sales) Third Amendment Regulations (March 8, 2021), Food Safety and Standards (Food Product Standards and Food Additive) Amendment Regulations (December 29, 2020), and Food Safety and Standards (Labeling and Display) Regulations (November 17, 2020) will be operationalized.

Subject: Direction under Section 18(2)(d) read with Section 16 (5) of Food Safety and Standards Act, 2006.

Reference is drawn to notifications:

- i) Food Safety and Standards (Prohibition and Restrictions on Sales) Third Amendment Regulations, 2021 dated 8th March, 2021 vide no. Stds/SP-15/T[T(IMST)] regarding change in nomenclature of Blended Edible Vegetable oil as Multi Source Edible Vegetable oil which is effective for compliance from 08.06.2021.
- ii) Food Safety and Standards (Food Product Standards and Food Additive) Amendment Regulations, 2020 dated 29th December,2020 vide no. F. No. 1-116/ Scientific Committee/Notif./2010-FSSAI regarding change in nomenclature of Blended edible Vegetable oil as Multi Sourced Edible Vegetable oil.
- iii)Food Safety and Standards (labelling and display) regulations,2020 dated 17th November 2020 vide no. F. No. 1-94/FSSAI/SP(Labelling)/2014(Pt-2) which is effective for compliance from 17.11.2021.

2. Whereas, considering the concern regarding labelling and the need to align the nomenclatures at point i) and ii) above, the Food Authority in its 33rd Meeting held on 23 March,2021 has decided to remove the term "vegetable" and change the nomenclature as "Multi Source Edible Oil" wherever it is specified in the FSS Regulations.

3. Representation were also received from the stakeholders requesting to extend the date of compliance of the Food Safety and Standards (labelling and display) regulations,2020 from 17.11.2021 in light of several amendments w.r.t. Font size, nomenclature of multi-source edible oil, Warning/statements on sweeteners and others which have been agreed by the scientific panel.

3. Accordingly, the Food Safety and Standards (Prohibition and Restrictions on Sales) Amendment Regulations, 2021, Food Safety and Standards (Food Product Standards and Food Additive) Amendment Regulations, 2021 and Food Safety and Standards (labelling and display) Amendment regulations, 2021, as enclosed, are operationalized with effect from 17.11.2021 to address the concern.

4. Further, the FBOs 'may continue to use the nomenclature either the old stock/inventory of tables containing the name 'Blended Edible Vegetable Oil' or 'Multi Source Edible Vegetable Oil' or 'Multi Source Edible Oil' on the label till 17.11.2021.

5. This issues with the approval of the Competent Authority in exercise of the power vested with Food Authority under Section 18(2)(d) read with Section 16 (5) of Food Safety and Standards Act, 2006.

Notice for operationalization of Draft Food Safety and Standards (Prohibition and Restrictions on Sales) Amendment Regulations, 2021-

Food Safety and Standards Authority of India, herby makes the following regulations operational with effect from 17.11.2021

- 1. These regulations may be called the Food Safety and Standards (Prohibition and Restrictions on Sales) Amendment Regulations, 2021.
- 2. In the Food Safety and Standards (Prohibition and Restrictions on Sales) Regulations, 2011, in regulation 2.3 relating to —Prohibition and Restriction on sale of certain products, in sub-regulation 2.3.14, for clause (11), for the words "Multi Source Edible Vegetable Oil" wherever they occur shall be substituted as "Multi Source Edible Oil".

Notice for operationalization of Draft Food Safety and Standards Food Product Standards and Food Additive) Amendment Regulations, 2021.

Food Safety and Standards Authority of India, herby makes the following regulations operational with effect from 17.11.2021

Regulations

- 1. These regulations may be called the Food Safety and Standards (Food Product Standards and Food Additive) Amendment Regulations, 2021.
- In the Food Safety and Standards (Food Products Standards and Food Additives) Regulations, 2011, in regulation 2.2, in sub-regulation 2.2.1, in clause 24, the words "Multi Sourced Edible Vegetable Oil" shall be substituted as "Multi Source Edible Oil".

Notice for operationalization of draft Food Safety and Standards (Labelling and Display) Amendment Regulations, 2021

Food Safety and Standards Authority of India, hereby makes the following regulations operational with effect from 17.11.2021.

1. (1) These regulations may be called the Food Safety and Standards (Labelling and Display) Amendment Regulations, 2021.

"4. Every package containing an admixture of edible oils shall carry the following label declaration in bold capital letter immediately below its brand name/trade name on the front of pack, namely: -

"MULTI-SOURCE EDIBLE OIL"

(Name and nature* of edible oil)% by weight (Name and nature* of edible oil)% by weight

(*i.e. in raw or refined form)

For pack size less than one litre, the font size of the label declaration **"MULTI-SOURCE EDIBLE OIL"**, shall not be less than 3 mm with the length of declaration statement as 35

mm minimum and for label declaration "Name and Nature of edible oil....% by weight", font size shall not be less than 2 mm.

For pack size one litre to below 5 litre, the font size of the label declaration "MULTI-SOURCE EDIBLE OIL" shall not be less than 4 mm with the length of declaration statement as 45 mm minimum and for label declaration "Name and Nature of edible oil.....% by weight" font size shall not be less than 2.5 mm.

For pack size five litre and above, the font size of the label declaration **"MULTI-SOURCE EDIBLE OIL"** shall not be less than 10 mm and for label declaration "Name and Nature of edible oil.....% by weight" font size shall not be less than 3 mm.

There shall also be the following declaration in bold capital letters along with the name of product on front of pack,-
