## **Report Highlights:**

Turkey requires the foreign competent authority to issue and sign a manufacturer certificate for imports of plant protection products (PPPs). U.S. Chambers of Commerce and State Departments of Agriculture are authorized to sign the certificates for PPPs from the United States. The required certificate template is included in this report; no other format is allowed.

## **Shipping PPPs to Turkey:**

The General Directorate of Food and Control (GDFC) under the Ministry of Agriculture and Forestry is the competent authority that is responsible for developing and implementing policy for all plant protection products (PPPs). PPPs are regulated under <u>the Regulation on Licensing and Placing on the Market of Plant Protection Products</u> ("PPPs Regulation"), which was published in the Official Gazette on March 14, 2024.

The PPPs Regulation sets the rules and procedures for the licensing and placement of PPPs on the market. According to the regulation, PPPs include the following products:

- Pesticides (Fungicide, Insecticide, Acaricide, Nematicide, Fumigant, Herbicide, Defoliant, Desiccant, Rodenticide, Molluscicide, Insect Growth Regulator)
- Biopesticides (Microbial Pesticides and Plant Extracts)
- Biological Control Agent (Predators and Parasitoids)
- Biotechnical Control Products (Anti-feedants, Attractants, Repellents, Traps and Pheromones)
- Plant Growth Regulator and Activators (Bio-stimulants)

For the licensing of a new PPP for import purposes, the PPPs Regulation requires the foreign competent authority to issue a "Manufacturer Certificate" that specifies the manufacturer's name, place of production, name of the active substance, product formulation, and other information. GDFC has approved <u>U.S. Chambers of Commerce</u> and <u>State Agriculture Departments</u> as the competent authority to issue and sign the manufacturer certificate. Wasco City Manager's Office is also eligible to sign for PPPs produced at facilities within their jurisdiction.

In addition to signatures from the competent authority, the document must also be approved or apostilled by the Turkish Consulate or Embassy in the producing country. A list of Turkish Embassy and Consulates in the United States can be found <u>here</u>.

DGFC requires the competent authority to use a specific manufacturer certificate template. **No other format is allowed.** In June 2022, Turkey <u>notified</u> the template to the World Trade Organization SPS Committee. The same template is included in the annex of this report.

The manufacturer certificate is valid for the period defined by the competent authority on the certificate. The certificate must be renewed within three-months from expiration, otherwise the product license will be canceled. A new certificate must be obtained for newly licensed PPPs or when the place of production changes.
