Report Highlights:

On January 1, 2021, the Government of Morocco (GOM) published Circular # 6125/222, announcing the required tariff changes under the U.S.-Morocco Free Trade Agreement (FTA) for Calendar Year 2021. As of January 1, 2021, almonds, fresh apples and skinless chicken leg meat- not mechanically deboned were listed at zero tariff for an unlimited quantity.

On January 1, 2021, the Government of Morocco (GOM) published Circular [#6125/222](#), announcing tariff changes as required under the U.S.-Morocco Free Trade Agreement (FTA) for calendar year 2021. The circular includes tariffs, tariff-rate quotas (TRQs), tariff-rate quota administration, agricultural safeguard measures, and allocation procedures. As of January 1, 2021, almonds, fresh apples and skinless chicken leg meat- not mechanically deboned were listed at zero tariff for an unlimited quantity. The tables below lists these commitments:
