On September 12, 2022, the Sri Lanka Standards Institution (SLSI) notified draft amendment standards (number 1) to SLS 917:2018 for milk added drinks to the World Trade Organization (WTO). WTO members are invited to submit comments on notification G/TBT/N/LKA/51. The comment period expires on November 12, 2022. The amendment is issued as requested by industry in order to insert new food additives permitted under the CODEX General Standard on Food Additives (GSFA).

The amendment is issued as per the request of industry in order to insert new food additives permitted under CODEX General Standard on Food Additives (GSFA). Accordingly, the following food additives are permitted.
