	Having regard to the order of the Minister of Agriculture and Marine Fisheries <u>No. 4260-12 of 17 Safar 1434 (31 December</u> <u>2012)</u> on substances prohibited for use in livestock.
	Order:
	Article 1: The provisions of Article 1 of the order <u>No. 4260-12</u> are repealed and replaced as follows:
	"Article 1: In application of article 53, 2) of decree n°2-10-473 above-mentioned, the administration to any animal whose meat or products are intended for human consumption is prohibited, the substances appearing on the following list:
	- Antithyroid (thyrostatic) agents.
	 Stilbenes derived from stilbenes, their salts, and esters. Sterides, Oestradiol 17 β and its esterified derivatives. Agonist substances.
	- Bovine somatotropin. - Chloramphenicol.
	- Nitrofurans including furazolidone.
	- Arsenical and antimonial substances, except those authorised as veterinary medicinal products.
	 Aristolochia spp. and all its preparations. Resorcylic Acid Lactones (including Zeranol).
	- Chloroform. - Chlorpromazine. - Colchicine.
	- Dapsone.
	- Dimetridazole, Metronidazole, Ronidazole and other Nitroïmidazoles.

- Malachite green (MG) and leucobase (LMG).

- Violet Crystal (VC) and Leucobasis (LCV).

- Brilliant Green (BG).

- Antibiotics for purposes or animal species other than those provided for in their marketing authorizations.

- All other medicinal substances for purposes or animal species other than those provided for in their marketing authorizations.
- All antimicrobial substances used for the purpose of promoting growth or increasing yield.
- All antimicrobial agents or groups of antimicrobial agents listed below.
