This report includes data for September, some of which is preliminary. After the publication of the November 2020 WASDE Report, this report will be updated with final numbers.

The FY 2021 WTO raw sugar tariff-rate quota (TRQ) shortfall is projected at 99,208 STRV. No information is available about specific countries.

On September 10, USDA increased the FY 2020 WTO raw sugar TRQ by 90,718 MTRV. USDA also extended the entry period by 1 month to October 31, 2020.
