**Report Highlights:**

On December 31, 2025, the Government of Mexico extended the Presidential Anti-Inflation Decree through the end of 2026 and narrowed eligibility for duty-free agricultural imports from non-free trade agreement suppliers. On January 5, 2026, Mexico's Secretariat of Economy published several administrative acts that put in place tariff-rate quotas for non-free trade agreement suppliers for several categories of products that were removed from the Anti-Inflation Decree, including beef and livestock, pork, and paddy rice.

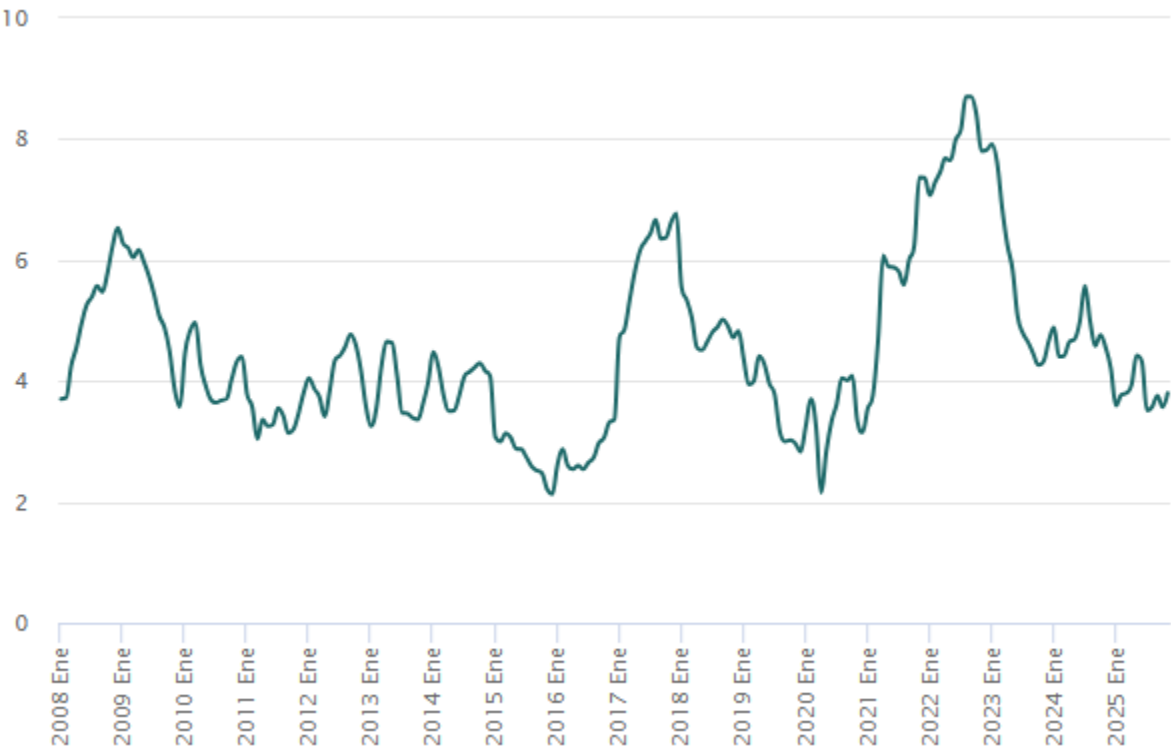
**Background on Updates to 2026 Anti-Inflation Decree**

On December 31, 2025 Mexico published an [extension](#) of the Presidential Anti-Inflation Decree through December 31, 2026. The decree provides tariff exemptions for a list of agricultural products imported from countries without free trade agreements. These exemptions only apply to products imported from registered companies listed in the “Register of Importers of Products of the Basic Basket.” Companies registered under the program may continue to apply the decree’s benefits through March 31, 2027.

The updated decree removed certain agricultural products that had previously been eligible for duty-free importation from non-free trade agreement (non-FTA) trading partners, including beef, pork, and paddy rice. A full list of changes is included starting on page 3 below.

The extension aims to control food price inflation. As of November 2025, Mexico’s National Consumer Price Index stood at 3.8 percent, nearly 1 percentage point lower than the same period in 2024. However, food price inflation increased to 5.1 percent in December 2025, up 1.5 percentage points year-on-year. Beef, pork and poultry meat registered annual price increases of 17.6, 4.85 and 2.4 percentage points, respectively.

## **Publication of New Tarriff-Rate Quotas**

On January 5, 2026, the Secretariat of Economy published three separate administrative acts in the Official Gazette establishing TRQs for [beef](#), [pork](#), and [paddy rice](#). The agreements are valid through December 31, 2026. Under these measures, imports from non-free trade agreement (non-FTA) suppliers may enter Mexico duty-free within the specified quota volumes; imports above the quota are subject to the applicable MFN tariffs. The full list of HS codes is included in table 1 below.

## **Key Changes Made by Update to Anti-Inflation Decree and Administrative Acts**

### **Beef**

- Live cattle and beef were removed from the program (HS codes: 0102.29.99; 0201.10.01, 0201.20.91, 0201.30.01, 0202.10.01, 0202.20.91, 0202.30.01).
- Beef from non-FTA suppliers will be eligible for duty-free access within newly established tariff-rate quotas. Imports exceeding the quota volume will be subject to Mexico's Most Favored Nation (MFN) tariff of 20 percent for fresh or chilled beef and 25 percent for frozen beef.

### **Pork**

- Pork was removed from the program (HS codes: 0203.11.01, 0203.12.01, 0203.19.99, 0203.21.01, 0203.22.01, 0203.29.99).
- Pork from non-FTA suppliers will be eligible for duty-free access within established tariff-rate quotas. Imports exceeding the quota volume will be subject to Mexico's MFN tariff of 20 percent.

### **Milk**

- Milk and milk powder were removed from the program (HS codes: 0401.10.02, 0401.20.02, 0401.40.02, 0401.50.02, 0402.10.01, 0402.10.99, 0402.21.01, 0402.21.99, 0402.29.99).
- Imports of milk and milk powder from non-FTA countries will be subject to Mexico's MFN tariff of 10 and 45 percent respectively.
- The Decree cites increased domestic investments in milk drying and pasteurization infrastructure as the main justification to remove milk and milk powder from the program.

### **Beans**

- Beans were removed from the program (HS codes: 0713.31.01, 0713.32.01, 0713.33.99, 0713.34.01, 0713.35.01, 0713.39.99).
- Imports of beans from non-FTA countries will be subject to Mexico's MFN tariff of 10 and 45 percent (white, black and other beans).
- The Decree cites higher precipitation and domestic production as the main justification to remove beans from the program.

## Rice

- Paddy rice was removed from the program (HS code:1006.10.99).
- Paddy rice from non-free trade agreement (non-FTA) suppliers will be eligible for duty-free access within established tariff-rate quotas. Imports above the quota will be subject to Mexico's MFN tariff of 9 percent.
- The Decree cites higher domestic production goals as a justification to remove milled rice from the program.

## Soybean Oil

- Soybean oil was removed from the program (HS code: 1507.90.99).
- Imports of soybean oil from non-FTA countries will be subject to Mexico's MFN tariff of 5 percent.

## Sunflower Seed Oil

- Sunflower seed oil was removed from the program (HS code: 1512.19.99)
- Imports of sunflower seed oil from non-FTA countries will be subject to Mexico's MFN tariff of 5 percent.

## Sausages and Similar Meat Products

- Sausages and similar meat products were removed from the program (HS code: 1601.00.03)
- Imports of sausages and similar meat products from non-FTA countries will be subject to Mexico's MFN tariff of 15 percent.
