Report Highlights:

Effective January 1, 2026, China will eliminate the tentative MFN tariff rates previously applied to fresh and dried cranberries, as well as specific types of frozen fish, according to a tariff adjustment plan published on December 29, 2025. The MFN tariff rates will increase ten percent for cranberries and one percent for select frozen fish products. This report contains an unofficial translation of the 2026 tariff adjustment plan and a list of agriculture-related products subject to tentatively applied MFN tariff rates.

Background

On December 29, 2025, the Ministry of Finance published an announcement from the State Council Tariff Commission (SCTC) detailing China's 2026 tariff adjustment plan. SCTC also announced China's tariff rate quotas (TRQ) for certain commodities.

This GAIN report provides an unofficial translation of the 2026 tariff adjustment plan, a table of agriculture-related products currently subject to tentative Most-Favored -Nation (MFN) tariff rates (Table 1), and a list of commodities under TRQ administration (Table 2). Each year, SCTC announces tentative import and export tariff rates for select commodities, effective for the following year. These tentative rates, typically lower than standard MFN tariffs, remain in effect until SCTC terminates them. Currently, China applies tentative MFN tariff rates to 935 tariff lines.

Notable Tariff Adjustments in 2026

Effective January 1, 2026, the tentative tariff rates currently applied to fresh cranberries, dried cranberries, and specific frozen fishery products will revert to their standard MFN tariff levels. Under the 2026 tariff adjustment plan, the tariff for fresh cranberries (HS 08104000) will double from 15 percent to 30 percent, and the rate for dried cranberries (HS 08134090) will increase from 15 percent to 25 percent. Similarly, frozen fishery products classified under HS 03034510, 03034520, and 03034600 will see a rate hike from six percent to seven percent. It is important to note that other agriculture-related products with tentative MFN rates previously announced by the SCTC will remain unchanged.

SCTC Announcement No. 11, 2025

In order to thoroughly implement the spirit of the 20th National Congress of the Communist Party of China and its subsequent plenary sessions, guide the development of new productive forces, continuously meet the people's needs for a better life, support high-level opening up, and promote high-quality development, in accordance with the "Customs Law of the People's Republic of China" and relevant regulations, adjustments will be made to the import tariff rates and tariff classifications of some commodities effective January 1, 2026. The specific details are provided in the attachment.

2026 Tariff Adjustment Plan

I. Tentative Import Tariff Rates

Tentative import tariff rates will be implemented for 935 commodities (excluding tariff rate quota commodities) (see Appendix 1).

II. Tariff Rate Quota (TRQ) Tariff Rates

TRQ administration will continue to be implemented for eight categories of imported commodities, such as wheat, with no change in tariff rates. Of which, a tentative in-quota tariff rate of one percent will continue to be applied to three fertilizers including urea, compound fertilizers, and diammonium phosphate. Continue to apply tentative tariff rates on certain quantities of cotton imported outside the quota in the form of a sliding tax (see Appendix 2).

III. Export Tariff Rates

Export tariffs will continue to be levied on 107 commodities, such as ferrochrome. Of which 68 commodities will be applied with tentative export tariff rates (see Appendix 3).

IV. Tariff Lines and Notes

Adjustments will be made to some tariff lines and domestic sub-lines notes (see Appendices 4 and 5). After the adjustments, there will be 8,972 domestic sub-lines and 201 sub-line notes.

V. Conventional Tariff Rates

Based on 24 free trade agreements (FTA) and preferential trade arrangements signed and entered into force with 34 trading partners, conventional tariff rates will continue to be applied to certain imported goods originating from these trading partners. First, further tariff reductions will be implemented according to the relevant agreements. The conventional tariffs will be further reduced in accordance with the FTAs between China and New Zealand, Peru, Switzerland, South Korea, Australia, Pakistan, Mauritius, Cambodia, Nicaragua, Ecuador, Serbia, and the Maldives, and the Regional Comprehensive Economic Partnership Agreement (RCEP). Second, the corresponding conventional tariff rates will continue to be applied to relevant imported commodities for which tariff reductions have already been completed. The FTAs between China and ASEAN, Chile, Singapore, Georgia, Iceland, and Costa Rica, the early harvest arrangement of the China-Honduras Free Trade Agreement, the Closer Economic Partnership Arrangement (CEPA) between mainland China and Hong Kong and Macau, the Economic Cooperation Framework Agreement (ECFA) across the Taiwan Strait, and the Asia-Pacific Trade Agreement will continue to be implemented as stipulated. VI. Preferential Tariff Rates

I) Continue to grant zero tariff treatment to 100 percent of tariff lines for 43 least developed countries with which China has established diplomatic relations, implementing preferential tariff rates. For TRQ commodities, only the in-quota tariff rates will be reduced to zero, while the tariff rate outside the quota remains unchanged.

II) In accordance with the Asia-Pacific Trade Agreement and the exchange of notes agreements between China and relevant ASEAN member states, continue to implement preferential tariff rates for certain imported goods originating from Bangladesh, Laos, Cambodia, and Myanmar. (see Appendix 6)

The above plan will be implemented from January 1, 2026.
