# **Report Highlights:**

On February 13, President Trump and Prime Minister Modi issued a joint statement announcing lower tariffs on bourbon whiskey. Following the statement, the Government of India published a customs notification lowering the customs duty on imported bourbon whiskey from 150 percent to 100 percent, effective immediately, while the duty on all other alcoholic beverages remains unchanged at 150 percent.

# **Reduced Bourbon Whiskey Tariff**

India maintains high applied tariffs on alcoholic beverages severely restricting access for U.S. spirits exporters, with current rates at 50 percent basic custom duty plus 100 percent agriculture infrastructure and development cess (AIDC). Following the <u>U.S.-India joint statement</u>, the Government of India published a <u>customs notification</u> lowering the 100 percent AIDC on bourbon whiskey (*HS code 2208 3011 and 2208 3091*) to 50 percent effectively bringing the overall import duty on bourbon whiskey to 100 percent.
