Report Highlights:

On March 12, 2024, the People's Republic of China (PRC) National Health Commission (NHC) and State Administration for Market Regulation (SAMR) jointly published an Announcement on releasing 47 new or updated National Food Safety Standards (known as Guo Jia Biao Zhun, or GB Standards) and 6 amendments sheets. The new or updated GB standards cover food additives, nutritional fortification substances, milk powder, food contact materials, microbial testing methods, and testing for arsenic and nickel. This report provides an unofficial translation of the Announcement. Stakeholders should conduct their own review of the regulations.

Summary:

On March 12, 2024, the People's Republic of China (PRC) National Health Commission (NHC) and State Administration for Market Regulation (SAMR) published an <u>Announcement on</u> <u>Releasing 47 National Food Safety Standards and 6 Amendment Sheets</u> (link in Chinese).

The new or updated GB standards cover food additives, nutritional fortification substances, milk powder, food contact materials, microbial testing methods, and testing for arsenic and nickel.

The full texts of the newly published standards in Chinese can be downloaded from <u>China's</u> <u>Food Safety Standards Search Platform</u> (only accessible from within China's internet domain), or the <u>China National Center for Agricultural Products Quality and Safety website</u>.

On March 13, 2024, NHC published an updated <u>National Food Safety Standards Catalog</u> <u>containing 1,610 standards</u> (link in Chinese). The 47 new or updated GB standards mentioned in this report have been added into the Catalog. Please refer to FAS GAIN Report <u>CH2023-0145</u> for the translation of the full Catalog in 2023.

Most of the new and updated standards in the Announcement were notified to the World Trade Organization (WTO) in 2021 and 2022 and the rest were notified earlier from 2018 through 2020. This report provides an unofficial translation of the Announcement and a list of the newly published standards. Stakeholders should conduct their own review of the regulations.
