Report Highlights:

On June 2, 2023, China notified to the World Trade Organization (WTO) under G/SPS/N/CHN/1278/Add.1 the amended Entry and Exit Inspection and Quarantine Phytosanitary Certificate for Re-Export of China. The phytosanitary certificate amendments provide updates to previously notified G/SPS/N/CHN/1278. This report provides a link to the amended certificate and includes the template as an appendix.

Summary:

On June 2, 2023, China notified to the WTO under <u>G/SPS/N/CHN/1278/Add.1</u> that the Phytosanitary Certificate for Re-Export of China notified in G/SPS/N/CHN/1278 has been amended. It includes partial modifications to the phytosanitary certificate.

On April 14, 2023, China notified two updated certificates, the Entry-Exit Inspection and Quarantine Phytosanitary Certificate and the Entry-Exit Inspection and Quarantine Phytosanitary Certificate for Re-Export, to the WTO under <u>G/SPS/N/CHN/1278</u>. The new versions of the Phytosanitary Certificate and Phytosanitary Certificate for Re-Export have been implemented since June 1, 2023 (please see FAS GAIN report <u>CH2023-0071</u>).

Compared with previously notified Phytosanitary Certificate for Re-Export, the newly amended template includes new information such as treatment method, and chemical and concentration information under the disinfestation and/or disinfection treatment section.

This report provides a link to the modified certificate and includes the template as an appendix.
