Report Highlights:

On October 18, 2023, China's Food Safety Standards Monitoring and Evaluation Department of the National Health Commission (NHC) published an announcement soliciting public comments on eleven national food safety standards. The announcement listed eleven national food safety standards including three food additives, four food products, one nutrition and special dietary food, one production operation rule, and two food-related products. This report contains an unofficial translation of the Announcement and the list calling for public comments.



Summary:

On October 18, 2023, the NHC released an "Announcement from the Secretariat of the National Food Safety Standard Review Committee on Soliciting Public Comments of Eleven National Food Safety Standards (link in Chinese)." The announcement included a list of eleven national food safety standards including one nutrition and special dietary food, four food products, three food additives, one production operation rule, and two food-related products. The written comments must be submitted to the Secretariat via the national food safety standards management information system (https://sppt.cfsa.net.cn:8086/cfsa_aiguo) before December 15, 2023.

The standards that are open for comments include:

- one nutrition and special dietary food
- four food products
- three food additives
- one production operation rule
- two food-related products
