Report Highlights:

On December 21, 2023, the State Council Tariff Commission (SCTC) announced its annual tariff adjustment plan that sets tentative import and export tariff rates for select commodities in 2024. According to the plan, China will tentatively eliminate the import tariffs for sweet corn seeds, coriander seeds, burdock seeds, and dairy-based formula foods for special medical purposes in 2024. The report contains an unofficial translation of the 2024 tariff adjustment plan, a list of agriculture-related products subject to tentatively applied MFN tariff rates and a commodity list subject to tariff rate quotas (TRQ) administration.

General Information

On December 21, 2023, the Ministry of Finance published on its website the 2024 tariff adjustment plan. The applied MFN tariff rates will be tentatively lowered for 1,010 tariff lines as of January 1, 2024, including those with tentative tariff rates previously announced by SCTC. In addition, SCTC also announces China's tariff rate quotas (TRQ) for certain commodities. At the end of each year, SCTC announces tentative import and export tariff rates for select commodities to be applied in the coming year.

This GAIN report contains an unofficial translation of the 2024 tariff adjustment plan, a list of agriculture-related products currently under tentative MFN tariff rate arrangement (Table 1) and a commodity list subject to TRQ administration (Table 2). Notable Tariff Adjustments in 2024

As of January 1, 2024, China will tentatively eliminate the import tariffs for sweet corn seeds (HS 07129099), coriander seeds (HS 09092100), and burdock seeds (HS 12119039). Meanwhile, the import duties for dairy-based formula foods for special medical purposes (HS 19019000) will also be eliminated.

Almost all agriculture-related products with tentative MFN tariff rates, which were announced by SCTC in the previous years, will remain in place.

Notice of the State Council Tariff Commission on the 2024 Tariff Adjustment Plan

December 20, 2023

SCTC Notice No. 10 (2023)

In order to completely, accurately, and comprehensively implement the new development concept, accelerate the construction of a new development pattern, and better perform the important function of tariffs in coordinating the two resources of the domestic and international markets, the import and export tariffs on certain commodities will be adjusted as of January 1, 2024, in accordance with the Regulations of the People's Republic of China on Import and Export Tariffs and the relevant provisions. Refer to Annexes for details.

The 2024 Tariff Adjustment Plan

- I. Import Tariff Rate
- 1. Tentative Import Tariff Rate

Tentative import tariff rates will be applied to a total of 1,010 commodities (not including commodities subject to TRQ). (see Annex 1).

2. TRQ Tariff Rate

TRQ administration will continue to apply to eight categories of commodities such as wheat and the tariff rates remain unchanged, of which a tentative in-quota tariff rate of one percent will continue to be applied to three fertilizers including urea, compound fertilizer, and diammonium phosphate. A sliding tax will continue to be levied on out-quota imported cotton within a certain amount (see Annex 2).

3. Conventional Tariff Rate

1) Based on the trade agreements and preferential tariff arrangements signed between China and certain countries or regions, conventional tariff rates will be applied to imported products from 30 countries (regions) under 20 agreements: a) Based on the free trade agreements (FTA) signed between China and New Zealand, Peru, Costa Rica, Switzerland, Iceland, South Korea, Australia, Pakistan, Mauritius, and

Cambodia as well as the Regional Comprehensive Economic Partnership Agreement (RCEP), the conventional tariff rates will be further reduced. b) The FTA between China and ASEAN, Chile, Singapore, and Georgia, the early harvest under the FTA between China and Nicaragua, as well as the *Closer Economic and Trade Relations Arrangement (CEPA)* between Mainland China and Hong Kong and Macau, have completed the tariff reduction process and the conventional tariff rates will continue to be applied. c) The Asia-Pacific Trade Agreement will continue to be implemented. d) The *Cross-Strait Economic Cooperation Framework Agreement (ECFA)* has completed the tariff reduction process and the conventional tariff rates will continue to be applied, except for goods involved in the Announcement of the State Council Tariff Commission on the Suspension of Tariff Concessions for Certain Products under ECFA (SCTC Notice No.9, 2023). Refer to Annex 3 for a tariff rate table under FTA and preferential trade arrangements.

- 2) According to the Free Trage Agreement between the Government of the People's Republic of China and the Government of the Republic of Nicaragua (hereinafter referred to as the Comprehensive Agreement), the year 1 tariff rates will be applied to certain imported goods originating in Nicaragua. The early harvest tariff concessions of the FTA between China and Nicaragua will be incorporated into the Comprehensive Agreement and implemented accordingly (see Annex 3).
- 3) When the most favored nation (MFN) tariff rates are lower or equal to the conventional tariff rates, they shall be implemented in accordance with the provisions of relevant agreements if there are such provisions. If there are no such provisions, the lower rates shall apply.

4. Special Preferential Tariff Rate

Continue to provide zero tariff treatment, or special preferential tariff rates, to 43 least developed countries that have established diplomatic relations with China and have completed the process of exchange of letters. The scope of commodities and tariff rates remain unchanged. The zero-tariff treatment will no longer be provided to Vanuatu.

II. Export Tariff Rate

Export tariffs will continue to be applied to 107 commodities such as ferrochrome. Of which, 68 commodities will be applied with tentative export tariff rates (see Annex 4).

III. Tariff Lines

Certain tariff lines and notes will be adjusted according to domestic needs (see Annex 5). After the adjustment, the tariff lines will total 8,957 in 2024.

IV. Implementation Time

The above plan will be implemented as of January 1, 2024, unless otherwise specified.
