Ecuador European Union Agriculture Trade 1 Year into Trade Agreement

Report Highlights:

On January 1, 2017 Ecuador's entry into the European Union's Andean Multiparty Trade Agreement took effect. One year into implementation, Ecuador maintains a large surplus of \$2.6 billion over the European Union's agricultural exports. At the same time, the competitive advantage granted to the European Union is becoming evident as it begins to capture more of the market. The European Union's agricultural exports grew about 22 percent in 2017 to an estimated \$146 million.

Executive Summary:

The European Union began implementation of a comprehensive trade agreement with Colombia and Peru in 2013. Negotiations for Ecuador's accession to the Andean Multiparty Trade Agreement concluded in 2014. Starting on January 1, 2017 Ecuador and the European Union started applying the Andean Multiparty Trade Agreement. With a record \$3.1 billion in agricultural exports, Ecuador maintained a significant surplus (\$2.6 billion) in its bilateral agricultural trade balance with the European Union. However, preferences given to the European Union have provided it with a competitive advantage that is enabling it to increase its share in the market. As a result, the European Union's agricultural exports increased by 22 percent in 2017 reaching an estimated record \$146 million in agricultural exports to Ecuador. The European Union's agricultural exports have increased significantly in the case of feeds and fodders, dairy and cheese products, fresh fruit, wine, and beer. In the case of dairy and cheese, the European Union's products appear to be enjoying a privileged market position since it is almost impossible for Ecuadorian importers to obtain an import authorization for products from the United States. Preferential tariffs negotiated for wine and beer are also giving the European Union a competitive edge over the United States. The European Union also exports of feeds and fodders, fresh fruit, and planting seeds that directly compete with U.S. exports of these products. Preferential tariffs and eased import authorization procedures for these products are expected to increase the European Union's market share in Ecuador.

The European Union determined that Ecuador would no longer be a beneficiary of European Union Generalized System of Preferences (GSP) as of December 31, 2016. By joining the Andean Multiparty Trade Agreement, Ecuador was able to maintain and expand preferential market access to the European Union. Ecuador mainly exports food and agricultural products to the European Union.

Background:

On January 1, 2017, Ecuador and European Union began implementing the Andean Multiparty Trade Agreement. Colombia and Peru are also party to this trade agreement, which originally entered into force in 2013. Negotiations for Ecuador's accession to the Andean Multiparty Trade Agreement concluded in 2014. Ecuador was a member of the initial trade negotiations for the agreement that began 2007, but it left them in 2009 for political reasons. At this time, Ecuador did not foresee negative trade consequences since it was a beneficiary of the European Union GSP. However, the European Union determined that Ecuador would no longer be a beneficiary of European Union GSP as of December 31, 2016. By joining the Andean Multiparty Trade Agreement, Ecuador was able to maintain and expand preferential market access to the European Union.

Ecuador Grants Market Access to Sensitive Products from the European Union:

Beef, poultry, chilled and frozen pork, and eggs were mutually excluded from the trade negotiations. However, as part of the Multiparty Trade Agreement, Ecuador has granted the European Union market access for several sensitive products in specific categories. Ecuador granted market access to processed meats such as Parma and Ibérico ham through a TRQ of 800 MT and will phase out tariffs in a period of 7 to 15 years. Ecuador granted full market access to animal fats, bacon and offals from the European Union. There is an additional 800 MT TRQ for processed meat products (cooked, grilled or baked) that will increase by 24 MT per year and for which tariffs will be eliminated in 15 years. Other Andean

countries in the Multiparty Trade Agreement negotiated market access to sensitive EU products separately.

Ecuador and the European Union excluded milk from their negotiations meaning that import tariffs will remain in place. Nevertheless, Ecuador granted minimum access through a TRQ for fluid and powder milk (400 MT increasing by 20 MT each year) and evaporated and condensed milk (600 MT with an annual increase of 30 MT). It also agreed to tariff phase outs for a few products. Tariffs on whey imports, for example, will be phased out in 5 years. Tariffs on cheese, ranging from 20 to 25 percent, will be phased out in 3 to 4 years. Ecuador also granted a TRQ of 500 MT per year with an annual increase of 25 MT up to 925 MT for cheeses for which tariffs will be phased out in 3 years. For cheeses with tariffs phasing out in 4 years, there is an additional TRQ of 1000 MT, which will grow by 50 MT per year up to 1,850 MT. These tariffs are specified by HS code. Ecuador also opened a TRQ of 500 MT for animal feed and a TRQ of 800 MT for pet food that will increase by 24MT each year. Under the Multiparty Trade Agreement, Ecuador committed to eliminating the ad-valorem tariff for soybean meal over a 10-year period, although the variable tariff part of the Andean Price Band System will remain in place.

Ecuador-EU Bilateral Agricultural Trade on the Rise:

With a record \$3.1 billion in agricultural exports, Ecuador maintained a significant surplus (\$2.6 billion) in its bilateral agricultural trade balance with the European Union. However, the European Union's agricultural exports to Ecuador increased by 22 percent over the previous year in 2017 reaching an estimated record \$146 million in agricultural exports to Ecuador. Trade figures including FAS Quito estimates for the year 2017 are included below.

In 2017, the European Union saw increased trade in categories where it received improved market access. Several of these product categories compete directly with agricultural exports from the United States. Products that saw upticks in imports from the European Union include wheat and wheat flour (\$5 million, first significant trade); feeds & fodders (\$20 million, up 80 percent); planting seeds (\$4.8 million up 27 percent); snack foods (\$6 million, up .2 percent); dairy products & cheese (\$2.1 million, up 38 percent); fresh fruit (\$5.5 million, up 330 percent); processed fruit & vegetables (11.4 million, up 39 percent); wine & beer (\$5.2 million, up 266 percent); nursery products & cut flowers (\$8.7 million, up 5 percent); and pet food (\$1.8 million, up 45 percent). A summary of Ecuador's imports and exports of key commodities is summarized in the Annex.

Ecuador's major agricultural exports to the European Union included bananas, shrimp, tuna, cacao, coffee, flowers, palm oil and processed vegetables. The Multiparty Trade Agreement granted permanent beneficial treatment to these products including bananas, for which tariffs will be fully phased out by 2020. Without the extension of the European Union GSP system and the signing of the Multiparty Trade Agreement, Ecuador's tuna exports would have been levied a 24 percent tariff. Tariffs on other relevant products for Ecuador including roses, coffees, and broccoli also went to zero as of January 2017.

Geographic Indicators:

Following the signature of the Andean Multiparty Trade Agreement, Ecuadorian authorities began encouraging domestic producers to adhere to norms regulating the uses of about 100 Geographic Indicators (GIs) including *scotch*, *feta* cheese, *camembert de Normandie* cheese, *Roquefort* cheese, and *champagne*. Ecuador included two GIs as part of the Multiparty Trade Agreement; these are the *Montecristi* straw hat and cacao *arriba*.
