New Import Duty on Beverage content certain Ethyl Alcohol

Report Highlights:

A new Indonesian Ministry of Finance regulation imposes new import duties on alcoholic beverages containing ethyl alcohol as of April 7, 2010. Previous import duties were based on the percentage of the CIF.

General Information:

On April 7, 2010, the Ministry of Finance issued Regulation No. 82/PMK.011/2010, which imposed new import duties on alcoholic beverages containing ethyl alcohol. This regulation effectively changed the tariff from an ad valorem tariff to a specific tariff.

The following table reflects the new tariff rates for specific beverage products:
