Report Highlights:

Israel plans to conduct a review of the use of 34 chemicals, which are components of approximately 180 agrochemicals that local farmers currently use. The Israeli Plant Protection Services (PPIS) will conduct the review over the coming two years beginning in October 2021. This might lead to an update of Israel's maximum residue limit (MRL) list for agrochemical residues in both locally produced and imported fruits and vegetables. Interested stakeholders are invited to submit their comments to the technical committee.



Executive Summary:

The Ministry of Agriculture and Rural Development (MOAG) will review the use of 16 percent of the agrochemicals that Israeli farmers use today. Post expects that PPIS will advise MOAG and the Government of Israel to ban the use of tens of agrochemicals used in local agriculture, leading to an update of the country's MRL list for agrochemical residues in both locally produced and imported fruits and vegetables.

General:

In October 2021, as part of the multi-ministerial committee for the registration of agrochemicals, PPIS – which is a division of MOAG – is planning to begin a two-year review of 34 chemical components which can be found in 180 different agrochemicals approved today for use in Israel.

In the past decade, two similar reviews were conducted – from 2012-2014 and from 2017-2020. These two reviews led to the ban of more than 70 agrochemicals that were approved previously for local agriculture, including organic phosphates, triazines, and chloric carbonates.

This new review will cover 34 different chemicals used in several herbicides, pesticides, fungicides, and miticides (See Table 1). Its goal is to evaluate the benefits and harm of different chemicals approved today for use in Israel but are banned from use in the European Union. Most of the chemicals that will be reviewed are approved for use in the United States and in other OECD member countries. Banning or limiting the use of some of these chemicals that will be reviewed might lead to a trade barrier for some U.S. agricultural exports to Israel.
