#### **Report Highlights:**

In Japan Fiscal Year 2022, Japan's Ministry of Agriculture, Forestry and Fisheries (MAFF) awarded 677,714 metric tons of rice through the Minimum Access import system. MAFF awarded 13,742 tons of rice in the simultaneous buy and sell tenders, and the remaining 663,972 tons through ordinary market access tenders.

### **Background**

Annually, Japan's Ministry of Agriculture, Forestry and Fisheries (MAFF) imports approximately 682,000 metric tons<sup>1</sup> (milled) of rice to fill its World Trade Organization tariff rate quota (TRQ), commonly referred to as the Minimum Access (MA) rice quota. MAFF imports MA rice through two types of tenders.

MAFF sets aside 100,000 tons of the WTO TRQ to import table rice through Simultaneous Buy-Sell (SBS) tenders. MAFF imports the remaining quota volume, which includes any unused volume from SBS tenders, through Ordinary Market Access (OMA) tenders. MAFF sells rice imported through OMA tenders to buyers who typically use it for processed food products or as animal feed. MAFF also exports some rice tendered through the OMA system as food aid.

#### JFY2022 SBS Rice Tender Results

In Japan Fiscal Year (JFY)<sup>2</sup> 2022, MAFF awarded a total of 13,742 tons of rice through SBS tenders, the third lowest volume since Japan introduced the MA tender import system in JFY1995. MAFF reallocated the remaining 86,258 tons to the OMA tenders. Through the SBS tenders in JFY2022, MAFF awarded a total of 2,378 tons of U.S. rice, 1,208 tons of whole grain and 1,170 tons of broken, the lowest volume since JFY1995. 



Chart 1: JFY2022 SBS Tender Results by Supplier



### **JFY2022 OMA Rice Tender Results**

In JFY 2022, MAFF awarded a total of 663,972 tons in OMA rice tenders. MAFF awarded 208,000 tons of U.S. medium grain rice, accounting for 31 percent of the total OMA tendered rice, the lowest volume since JFY1996.

## **JFY2022 MA Rice Tender Results**

In JFY 2022, MAFF tendered a total of 677,714 tons through the MA rice tenders. MAFF awarded 210,378 tons, 2,378 tons of SBS and 208,000 tons of OMA, of U.S. rice in the WTO MA tenders, accounting for 31 percent of Japan's WTO MA rice market share.




Chart 5. MA Rice Tender Results (JFY2012- 2022)
