Report Highlights:

On January 18, 2024, the Ministry of Agriculture and Rural Affairs (MARA) announced the issuance of new and renewed biosafety certificates for genetically engineered (GE) events. The announcement includes one renewed and two new biosafety certificates issued for GE crops approved for import as processing materials, two new biosafety certificates issued for geneedited events for domestic cultivation and processing, two renewed and 17 new biosafety certificates issued for GE crops approved for domestic cultivation and processing, five renewed and seven new biosafety certificates for genetically modified microorganisms (GMMs) for animal use, and 29 renewed biosafety certificates for GE cotton approved for domestic cultivation and processing. The validity period of new and renewed biosafety certificates is five years.

Summary:

On January 18, 2024, MARA announced the issuance of new and renewed biosafety certificates for genetically engineered (GE) events. The announcement includes two new and one renewed certificate issued for GE crops approved for import as processing materials, including one renewed GE cotton event developed by Bayer, one new GE corn event developed by Corteva (applicant's name is Pioneer International Seeds), and one new GE soybean event developed by Chinese developer DaBeiNong (this event was previously approved for domestic cultivation by Argentina in November 2022 and approved by MARA for domestic cultivation and processing in April 2023).

The announcement also includes two new certificates issued for gene-edited soybean events for domestic cultivation and processing, 11 new certificates for GE corn events for domestic cultivation and processing, five new certificates for GE soybean events for domestic cultivation and processing, one new certificate for GE cotton event for domestic cultivation and processing, two renewed certificates for GE corn events for domestic cultivation and processing, five renewed certificates for GMMs for animal use (vaccines, biopharmaceuticals and feed additives use), seven new certificates for GMMs for animal use, and 29 renewed certificates for GE cotton events. All new and renewed biosafety certificates are valid for five years.
