Report Highlights:

The Democratic Socialist Republic of Sri Lanka's (Sri Lanka) Ministry of Finance, Economic Stabilization and National Policies recently introduced a Special Commodity Levy for three agricultural commodities: maize (corn), black gram, and green gram, effective August 18, 2023, for a period of sixmonths. The Sri Lankan government notified the new regulation in the Gazette of the Democratic Socialist Republic of Sri Lanka – Extraordinary (official gazette) No. 2345/64 on August 17, 2023. The introduction of the Special Commodity Levy (SCL) on maize (corn) reduces the import duty assessed on corn from Sri Lankan Rupee (LKR) 75.00 to LKR 25.00 per kilogram. Although the reduction in import duties for corn is welcomed by the international trade, U.S.-origin exports will be minimally impacted as U.S.-origin corn prices currently are higher compared to Indian-origin ones.

GENERAL INFORMATION

The Democratic Socialist Republic of Sri Lanka's (Sri Lanka) Ministry of Finance, Economic Stabilization and National Policies introduced a Special Commodity Levy for three agricultural commodities: maize (corn), black gram, and green gram effective August 18, 2023, for a period of sixmonths (see, Appendix I). The Sri Lankan government notified the new regulation in the Gazette of the Democratic Socialist Republic of Sri Lanka – Extraordinary (official gazette) No. 2345/64 on August 17, 2023.

New Regulation's Impact on U.S.-Origin Maize (Corn) Exports to Sri Lanka: The introduction of the Special Commodity Levy (SCL) on maize (corn) reduces the import duty assessed on corn from Sri Lankan Rupee (LKR) 75.00 to LKR 25.00 per kilogram (kg) for a six-month period effective August 18, 2023. Although the reduction in import duties for corn is welcomed by the international trade, U.S.-origin exports will be minimally impacted as U.S.-origin corn prices currently are higher compared to Indian-origin ones.

Even though the SCLs are applicable also to black gram and green gram, the import of these two commodities to Sri Lanka are currently temporary banned (black gram) and temporary suspended (green gram) to protect domestic Sri Lankan producers.

Order under Section 2

01. BY virtue of the powers vested in me under Section 2 of the Special Commodity Levy Act, No. 48 of 2007, I, Ranil Wickremesinghe, Minister of Finance, Economic Stabilization and National Policies of the Democratic Socialist Republic of Sri Lanka, do by this order impose in respect of the commodities specified in Column I of the Schedule hereto a Special Commodity Levy at the rate specified in the corresponding entries in Column II of that Schedule.
