## **Report Highlights:**

On December 22, 2023, Taiwan completed the last tender for 6,000 MT of U.S. long grain brown rice. This purchase concludes the tenders for the 2023 country specific quota (CSQ) for U.S. rice. Taiwan fulfilled 100 percent of its CSQ commitment to purchase 64,634 MT of U.S. rice.

## **General Information:**

On December 22, 2023, the Taiwan Ministry of Agriculture (MOA) and Bank of Taiwan (BOT) completed the last tender for U.S. rice in 2023. The contracts for long grain brown rice were awarded to one company for a total amount of 6,000 MT. With these sales, Taiwan fulfilled 100 percent of its 2023 country specific quota (CSQ) to purchase 64,634 MT of table rice from the United States. Of the CSQ, 28,800 MT were filled under the Simultaneous-Buy and Sell (SBS) regime for delivery by April 30, 2024 and 35,834 MT under the normal tender regime for delivery by December 31, 2024. This is a return to filling at or near 100 percent of the CSQ obligations, which saw a significant shortfall the previous year.

In November 2023, a tender for 1,000 MT (1,150 MT on brown basis) of U.S. Glutinous Short Grain Milled Rice was successfully filled after three rounds of bidding. This marked the first time since 2019 that a tender for glutinous short grain milled rice was concluded successfully in full.

Under the 2002 accession agreement to the WTO, Taiwan agreed to import 144,720 MT (brown basis) of rice annually, including 64,634 MT from the United States. The U.S. exported almost \$43 million of rice to Taiwan in 2022.
