Report Highlights:

On May 14, 2019, the Government of India's (GOI) Ministry of Finance (MOF) further deferred the implementation date, from May 16, 2019, to June 16, 2019, of the proposed increase in the basic custom duty (BCD) for exports of specific U.S. agricultural products (i.e. artemia, shelled and in-shell almonds, in-shell walnuts, fresh apples, and pulses).

On May 14, 2019, the MOF issued customs notification <u>15/2019</u> announcing a delay in the implementation of increases in the effective BCD for specific U.S. agricultural imports from May 16, 2019, to June 16, 2019. If implemented, these tariff increases would apply to exports of U.S.-origin shelled and in-shell almonds, in-shell walnuts, apples, artemia and pulses.

Background Information:

On June 20, 2018, the MOF issued notifications $\frac{48}{2018}$ and $\frac{49}{2018}$ announcing increases in the BCDs for these specified U.S.-origin agricultural products, effective August 4, 2018. (See GAIN IN8078)
