Report Highlights:

The U.S.-Japan Trade Agreement (USJTA) entered Year 5 of the agreement implementation on April 1, 2023. This report is one in a series of product briefs highlighting the tariff benefits for specific commodities and products from Year 5 (2023) to Year 7 (2025) of the Agreement. Overview: In 2022, the United States exported \$63 million of sugars (excl. lactose) and sugar confectionary to Japan. The United States accounted for over three percent of Japan's total imports of these products. Overall, Japan ranked as the #3 overseas sugar market for the United States. The years below correspond to Japan's fiscal year beginning April 1.
