Report Highlights:

The U.S.-Japan Trade Agreement (USJTA) has been in effect for 16 months, however the timing of Japan's fiscal year meant that the agreement entered "Year 3" of implementation on April 1, 2021. This report is one in a series of product briefs highlighting the tariff benefits for specific commodities and products from Year 3 (2021) to Year 5 (2023) of the agreement. Overview: In 2020, the United States exported \$115 million of vegetable preparations (excl. potatoes) and juice to Japan, making Japan the #2 overseas market for these U.S. exports. The United States accounted for 11 percent of Japan’s total vegetable preparations and juice imports. The years below correspond to Japan’s fiscal year beginning April 1.
