6.	<b>Description of content:</b> Prosulfocarb is an approved active substance in Great Britain (GB). An application was received by the Health and Safety Executive (HSE) requesting new Maximum Residue Levels (MRLs) for prosulfocarb in or on herbs and edible flowers. Following assessment, new MRLs have been introduced to set import tolerances for: Herbs and edible flowers from 0.05* mg/kg to 20 mg/kg.  The Evaluation Report/Reasoned Opinion supporting the new MRLs is available at the following link: <a href="#">The evaluation of new MRLs for prosulfocarb in or on herbs and edible flowers</a> .  The residue levels arising in food from the notified uses result in consumer exposures below the toxicological reference values. As the residue levels exceed the current MRLs in force, new MRLs are being adopted.  There are currently no CXLs for prosulfocarb.
