MRLs in raw agricultural commodities apply to their processed commodities (including pepper, dried and raisin) taking into account the processing factors. Therefore, the deletion of MRLs in pepper, dried and raisin will not strengthen the current regulation, and all the proposed MRLs conform to the Codex MRLs.</p>
